#### Counter Terrorism & Domestic Extremism

The lessons also cover political and historical terrorism and human safety versus human rights. The purpose of ACT NOW for schools is to encourage diverse communities to understand counter-terrorism issues and to feel confident about making decisions based upon the information they are given.
