4. Community Justice Update:

Margaret spoke to the update that had been circulated.

Libby mentioned a funding opportunity that could be circulated to the CJ Forum Attendees.

Brian updated the meeting about the Community Integration Plan pilot project between SPS, CJSW and NHS which will go to the Project Board. The My Compass assessment tool will be used within the prison for a few individuals and their progress will be tracked within the community. There will be an evaluation of the pilot. Housing is also involved with the pilot and Suzy can perhaps feed back how the project is going.

Niall offered support from the CJP if required.

5. Update on Chair:

Niall updated the meeting that applications had been received for the role and that interviews would be held on 14 December. The new Chair will officially take over the role from 1 April 2021.

6. Evidence of Link Worker Project Case Studies:

Alan spoke to the paper circulated to the meeting that there have been 25 cases dealt with so far and they are mainly people struggling to manage their lives rather than career criminals. Several meetings have taken place with agencies to discuss how things can be improved.

Suzy questioned the 18-24 month waiting time mentioned in the report and asked if this could be looked at and if it is a perception. Also is this information a deterrent for people trying to access the service.

James observed that there appears to be a lot of mental health issues. Alan updated they are looking at the potential gaps in service/referral routes as it appears that not everyone is receiving treatment or support.

Roddy enquired whether any training needs have been identified for Custody Link staff, Alan updated that this is constantly under review whilst engaging with services to learn more and striving to work better together.

It was understood that any issues can be reported back through the CJP Meetings.

Ross suggested the newly appointed Harm Reduction Officer Steve MacLean would be a good contact for the Link Workers

Mhairi mentioned about the organisations the clients are referred to and Alan mentioned that they encourage clients to self-refer to agencies.

7. Finance Update:

James updated the meeting that the money through the ledger remains the same as stated at the previous meeting.

8. Proposal for CJP Finances:

Mhairi spoke to the paper circulated suggesting that funding could be used to engage an analyst to provide a 1. Health check around the already existing data and 2. Link in with organisational analysts from CJP membership to assess what data would be useful going forward.

This should allow us to measure and monitor the impact of the CJP Plan. Discussion around the finances is due to take place.

The data will also be measure against other authorities to get an indication of where Highland sits.

Mhairi asked if the CJP would be in agreement to progress this piece of work.

AGREED this should be progressed

<u>Action</u> – Feed back to Margaret regarding the proposal to fund analytical work – All

Libby suggested speaking to Interface at UHI regarding this proposal and Mhairi agreed to consider.

Verbal agreement from James and Ross to progress.

9. Development of new CJ Plan:

Niall spoke to the paper that had been circulated outlining the proposal and timeline for the new CJ Plan. Discussion took place around ideas for inclusion in the plan with suggestions of digital inclusion and Other Activity for Unpaid Work.

Ross mentioned that there is access to funding for SOCG, perhaps for technology and this could be looked at.

Niall mentioned the Princes Trust and Brian mentioned that SPS work with them.

Action – Brian to send Niall information around the Princes Trust

<u>Action</u> – Niall, Mhairi and Margaret to discuss plan for development sessions to be held on Teams

10.AOCB:

Suzy mentioned the Harm Reduction Response Vehicle with police/ambulance/paramedic and drug & alcohol staff will be in use over December and January as part of Operation Respect. Suzy will report back as to the findings of this approach.

Mhairi updated that she had attended the Integrated Children's Board and thinks that the CJP needs to link into this although Sally sits across both. The CPC have set up a Youth Justice Group and this work is linked to the CJP. James mentioned the Youth Justice Improvement Group which straddles both child and adult services. Niall mentioned that it may be worth raising at the CP Coordinator's Group.

Mhairi also mentioned that after inheriting the Café in Church St, Inverness, this will be re-positioned as a drop-in centre whilst being run as a Café. There will be volunteers running this over the festive period serving hot food to those that need it. There is still work to be done around long-term funding for the Café.

<u>Action</u> – Margaret to circulate the flyer of the Café to the group with opening times etc.

Margaret Mentioned that she has recently sent out surveys to the CJP and their assistance in completion would be appreciated.

Niall raised that there had been discussion around attendance at the HPPCOG and provision of information to the group. CJP members are not listed as attendees on the TOR.

James mentioned that there is value in the CJP sharing information as there is a shared interest around the ADP, CPC and ASP agendas. He suggested that perhaps an annual report around data would suffice in relation to the provision of information.

Niall updated that a meeting had taken place between himself, James and Sheriff Pyle around Bail Supervision and CPOs. It was a positive meeting although further information is required in relation to what support is available for these measures. Crown Office would also need to look at national decisions around this.

In relation to a Sheriff attending the CJP, Sheriff Pyle seemed to be keen for this and acknowledged that it happens in other areas of Scotland.

<u>Action</u> – Niall to write to Sheriff Pyle with the request for attendance of a Sheriff at the CJP Meetings
