Purpose/Executive Summary

1.1 This report updates Members on recent work in on projects in the Highland area that have been funded through the Scottish Government's Rural Tourism Infrastructure Fund. It also provides an update on the position with a number of potential tourism infrastructure projects funding bids that might be put forward to the 4th round of the Rural Tourism Infrastructure Fund in summer 2021.

Recommendations

- 2.1 Members are asked to:
 - i. Note the current position with the Highland Rural Tourism Infrastructure Fund supported projects, and
 - ii. Note the tourism infrastructure projects that are currently being considered as potential bids to the 4th funding round that closes in summer 2021.

3. Implications

- 3.1 **Resource** The Council employs a Tourism Projects Coordinator who liaises with project leads and submits all Rural Tourism Infrastructure Fund applications and supporting evidence including for projects not being run by the Council. The costs of this post and activity are met from the Service budget. Where projects are led by the Council, the resources required are met by the services concerned.
- 3.2 **Legal** There are no implications arising directly from this report, but all projects funded by the Rural Tourism Infrastructure Fund or other grants are the subject of a legal agreement between the grant awarding body and the Council. Similar legal agreements are in place between the Council and any third parties delivering projects.

- 3.3 **Community (Equality, Poverty and Rural)** there are no implications arising directly from this report. However, the delivery of the projects described are expected to produce positive benefits for communities as well as for visitors.
- 3.4 **Climate Change / Carbon Clever** there are no implications arising directly from this report. However, projects have been developed with elements of sustainability in mind and these require to be detailed in the applications for Round 3 Rural Tourism Infrastructure Fund projects. Some elements of Rural Tourism Infrastructure Fund projects will specifically focus on infrastructure that can help reduce climate change impacts.
- 3.5 **Risk** There are no implications arising directly from this report.
- 3.6 **Gaelic** There are no implications arising directly from this report. However, in keeping with the Council's Gaelic policy there can be Gaelic elements to some of the infrastructure projects described.

4. Rural Tourism Infrastructure Fund

- 4.1 In October 2017 the First Minister Announced a £6m investment in a new Rural Tourism Infrastructure Fund with the first round of awards announced in October 2019 and the second round following in June 2019. A further £3m of funding was made available for a third round in 2020 with awards announced in January 2021.
- 4.2 The three rounds to date have seen over £3.5m awarded to Highland tourism infrastructure projects with some of those projects delivered directly by the Council and others delivered by community organisations with the Council as a supporting partner.
- 4.3 Recently a fourth round of the fund has been announced with a closing date for applications of 10 September 2021.

5. Rural Tourism Infrastructure Fund - Round 1 projects

5.1 The first round of the Rural Tourism Infrastructure Fund saw 6 Highland projects awarded funding with a total of just over £1.1m and a total project value of just over £1.6m. The current position with each of these projects is as follows:-

6. Rural Tourism Infrastructure Fund - Round 2 projects

6.1 The second round of the Rural Tourism Infrastructure Fund saw another 6 successful projects awarded funding. These applications include a total grant award of just over £1.5m and a total project value of just over 2.5m.

7. Rural Tourism Infrastructure Fund - Round 3 projects

7.1 The third round of the Rural Tourism Infrastructure Fund saw another 5 projects awarded funding. These approvals saw a total grant award of just over £800k (with one project still to be allocated a final funding figure) and a total project value of just over £1.5m.

As well as 5 approved projects a further 5 Highland projects were put on an approved waitlist; these would receive funding if any approved projects could not meet their conditions or if there was an underspend. However, the Highland Council are now awaiting news to see if additional funding will be made available by the Scottish Government to support all waitlist projects as well. The combined awards including the waitlisted projects would see a total grant award of over £1.6m and a total project value of over £3.2m.

8. Rural Tourism Infrastructure Fund – Potential round 4 projects

8.1 As mentioned in 4.3 above, a fourth round of the fund has been announced with a closing date for applications in September 2021. However, organisations seeking an early contribution as a "design grant" had to apply by 19 May 2021. Approaches made in relation to this have given an early indication of some of the projects that might go forward as full applications in September. Those potential applications that the Council is aware of at present are:-
