Mr G McMenemy, applicant, then spoke in support of his application during which he asked the Board to grant the application to provide him with an opportunity to prove he was a fit and proper person to hold a personal licence. He wished to reopen his premises to provide a service to the community for which there was demand, and provide employment both for himself and young people seeking work. The Clerk advised that the Board should consider only whether the applicant was a fit and proper person to hold a personal licence. If the Board considered then applicant was not a fit and proper person, then it should not grant a personal licence to provide the applicant with an opportunity to prove otherwise.

In response to questions from Members, Mr McMenemy outlined the actions he had taken to address his [text removed from web version in compliance with Data Protection Act 1998] issues and indicated he was confident there would be no issues arising with his conduct going forward if he was granted a personal licence.

Following discussion, the Board **AGREED** to **REFUSE** the application for a personal licence on the grounds that, having regard to preventing crime and disorder and securing public safety, the applicant is not a fit and proper person. 11. Review proposals – non-payment of annual premises licence fees Moladh ath-sgrùdaidh – neo-phàigheadh chìsean ceadachd togalaich bliadhnail

There had been circulated **Report No HLB/042/21** by the Clerk which invited the Board to make premises licence review proposals in respect of premises licences for which the annual fee has not been paid.

In response to questions, the Clerk explained that it was recognised this had been a difficult year for the trade due to the pandemic, however the number of premises which had not paid the annual fee at this stage was in line with previous years. It was anticipated the majority of premises listed in the report would either pay their annual fee or confirm they were no longer trading prior to the next meeting. To date, no premises had sought to negotiate a reduced fee, however individual premises would have the opportunity to put forward a case in this regard to the next meeting, albeit it was a mandatory condition that the annual fee was paid

The Board **AGREED** to **MAKE REVIEW PROPOSALS** for those premises which had not paid their annual fee and to hold review hearings at the next meeting of the Board on 22 June 2021 on the ground that non-payment of annual fees is a breach of mandatory condition 10 of the premises licence.
