Purpose/Executive Summary

- **Description:** Extension to existing Edinbane substation comprising platform area, indoor switching stations and substation buildings, associated plant and infrastructure, ancillary facilities, laydown area(s) and landscape works
- Ward: 10– Broadford and Strath

Recommendation

1.0 BACKGROUND

- 1.1 This report informs the Planning Applications Committee of the submission of the attached Proposal of Application Notice (PAN).
- 1.2 The submission of the PAN accords with the provisions of the Planning etc. (Scotland) Act 2006 and was made valid on 7 September 2021. The PAN is a statutory requirement for planning applications for major or national developments and must be lodged at least 12 weeks prior to the submission of a planning application. Members are asked to note this may form the basis of a subsequent planning application.
- 1.3 The submitted information attached includes:
 - Proposal of Application Notice (Application Form)
 - Location Plan
- 1.4 Due to relaxations in COVID-19 restrictions the prospective developer proposes to hold face to face public events on the dates noted below. They also intend to undertake a virtual event thereafter using online platforms for public engagement to allow local people to express their views and to submit questions to the applicant's project design team for live discussion. - 1.5 The virtual exhibitions will be accessed through : https://www.ssen-transmission.co.uk/projects/skye-reinforcement/
- 1.6 The consultation will be publicised and advertised in accordance with the appropriate statutory requirements with adverts to be placed within The Press and Journal, with a secondary advert also being placed in the West Highland Free Press. A written event invitation maildrop will also be undertaken by the applicant to make people aware of the proposed development. The catchment for its distribution has been agreed with the Planning Authority and will cover a 5km radius. Information will also be provided on the project website and on the applicants' social media outlets.
- 1.7 The forthcoming application will be accompanied by a Pre-Application Consultation (PAC) report explaining the consultation undertaken, feedback received, and any resultant amendments made to the planning application.

2.0 DESCRIPTION OF PROPOSED DEVELOPMENT

- 2.1 The PAN provides notice of the developer's intention to submit a planning application classified as a National Development. The proposal comprises the extension to existing Edinbane substation, including platform area, indoor switching stations and substation buildings, associated plant and infrastructure, ancillary facilities, laydown area(s) and landscape works.
- 2.2 The proposal is part of a wider programme of works known as the Skye Reinforcement project, to reinforce the existing electricity transmission connection from Ardmore to Fort Augustus to facilitate the connection of more renewable energy generation and maintain security of supply for Skye, as well as to the Western Isles which is supplied by subsea cables from the north of Skye.
- 2.3 The wider overhead line proposals are to be the subject of a separate application to the Scottish Government's Energy Consents Unit, under Section 37 of the Electricity Act 1989, the determination process for which requires further consultation with The Highland Council. The PAN relates to one of two substations in Skye which require to be upgraded as part of this wider project, both of which will be subject to separate planning applications under the Town and Country Planning Act 1997, as amended, for determination by The Highland Council.
- 2.4 Prior to lodging the PAN the developer has sought formal pre-application advice from the Planning Authority through the Pre-Application Advice Service for Major Developments.

3.0 SITE DESCRIPTION

- 3.1 The PAN boundary comprises 10.9 ha of the existing Edinbane Substation and surrounding moorland located approximately 6 km to the south of Edinbane settlement and 1.1km to the west of Glenvicaskill. The site lies between two areas of forestry. The topography of the site is generally gently sloping from south to north.
- 3.2 Much of the site is located within areas of deep peat and Class 1 Priority Peatland Habitat. To the north, lies Edinbane Wind Farm and a series of overhead electricity lines running East-West. To the south, the site boundary follows Balmenach Road and a Core Path runs parallel to the A850. To the east, there is an access point to the existing substation building taken from Balmenach Road. To the west of the site, the site is enclosed by a watercourse and coniferous woodland plantation of Mullach Glen Ullinish.
- 3.3 There are a number of built and heritage designations surrounding the site, most notably the Dun Arkaig Scheduled Monument lies approximately 1km to the south of the site. Further historic environment features are identified on the Council's Historic Environment Record.
- 3.4 The site itself is free from flood risk however areas surrounding the site there are indicative areas of fluvial flooding identified on the indicative flood risk maps produced by SEPA to the south western edge of the site as it bounds the watercourse.

3.5 The site lies within Upland Sloping Moorland Landscape Character Area as identified by NatureScot. To the south western corner of the site is identified as common grazings.
