The Chair confirmed that the meeting would be webcast and gave a short briefing on the Council's webcasting procedure and protocol.

Business

8.1 Premises – Zoom Takeaway, 23 Baron Taylor Street, Inverness

There had been circulated **Report No HLC/015/22** by the Principal Solicitor relating to the licence holder of late hours catering premises at Zoom Takeaway, 23 Baron Taylor Street, Inverness (Ward 14 - Inverness Central Ward).

The Senior Licensing Officer stated that following receipt of a request from the Council's Environmental Health department, the Principal Solicitor, in consultation with the Head of Corporate Governance, had immediately suspended Mr Afif's licence under Paragraph 12 of Schedule 1 of the Civic Government (Scotland) Act 1982.

A written submission had been received on behalf of the licence holder and had been circulated to Members prior to Committee.

The Committee heard from Environmental Health.

The applicant stated that the works required had taken some time due to Covid restrictions as the premises had been closed. He stated that he had been in the food business for more than 25 years and took the health of his customers very seriously. The works requested by Environmental Health had now been undertaken and were ready for inspection.

On a question, the Environmental Health Officer advised Members that the premises were currently closed due to the Remedial Action Notice which was still in place. The Notice would be reviewed once Mr Afif had submitted a satisfactory Food Safety Management Plan that met Article 5 of the relevant regulations. Once the plan had been received it would enable an Inspection Frequency Programme to be put in place and enable the business to operate.

The Committee **AGREED** to **SUSPEND THE LICENCE** for the unexpired portion of the duration of the licence, with immediate effect.

The decision was made in terms of paragraph 11(2)(c) of Schedule 1 of the Civic Government (Scotland) Act 1982 as the Committee deemed that the carrying on of the activity to which the licence relates is likely to cause a threat to public safety.

It was further agreed to **GRANT DELGATED POWERS** to the Principal Solicitor to lift the suspension if Environmental Health confirm that they are satisfied that (1) the premises is safe to operate and (2) all the required documentation has been submitted and is satisfactory.
