## 4. Grant Applications

- 4.1 The current summary of funds available following the Inverness Common Good Fund Sub-Committee meetings on 27 June 2022 and 15 August 2022 is set out in Appendix 1.
- 4.2 **Booklet A and Appendix 2** include details of current grant applications for more than £10,000. Members are invited to consider the following application:
  - i. Free North Church (Booklet A): The Inverness Common Good Fund Sub-Committee recommend refusal of a grant of £17,250. The Sub-Committee considered that the project has not identified that it would bring sufficient benefit to the citizens of Inverness.
  - **ii. City Decorative Lighting (Appendix 2):** Members are asked to consider the internal application from the Inverness City Area Manager and Principal Project Manager Housing & Property for a grant of £70,000 towards City Centre decorative lighting. This follows a decision taken at CIAC 17<sup>th</sup> February 2022, to set aside £100K towards improving decorative lighting, set aside in addition to the regular decorative (Festive) Lighting budget of £73k. This included a recommendation to the new Council to support a further allocation of up to £100K, should budgets permit, from the 22/23 ICGF budget. The grants budget has the capacity to support this application. The ICGF Sub-Committee has not considered this application given the previous determination from CIAC for this to come back to a future meeting of the CIAC.

We are seeking funding to replace the existing sound system in the sanctuary of the Free North Church. This will allow a wider range of microphones and instruments to be used through additional sound inputs on the platform. The upgrade will improve the reliability of the sound system compared to the current system. Safety will also be improved by the removal of existing trip hazards on the platform.

Modelling undertaken by the supplier of the system indicates that there will be a marked improvement in sound dispersion and coverage compared to the existing system. The improvement in sound quality would apply to all sources – microphones, media playback and instruments.

The project will benefit the regular congregation of the Free North Church and other users of the building. Concerts are held by different choirs in the building. Those given by the Acclaim Choir can attract over 500 people to the building. The University of the Highlands and Islands also use the building for graduation ceremonies. Weddings and funerals are held in the building. Each of these different uses of the building depend upon high quality sound, whether speech, music or media playback for those present to fully benefit from the event taking place.

Since the recent installation of livestreaming equipment, the benefit of any upgrades to the sound system will extend to those who are unable to attend the building in person and who participate in services and events online.

Feedback from within the congregation of the Free North indicates that there are some who struggle to hear well through the existing system. Sound quality from media playback is currently poor; the new system should lead to a significant improvement.

Currently the number of audio inputs at the platform is too limited with, for example, a single input serving both an instrument and voice which means that these cannot be controlled independently. Extra inputs at the platform will allow for more versatility in terms of available microphones and instrument inputs which will be of benefit for regular Free North services and also other events hosted in the building.

This project would complete a wider package of audio-visual upgrades undertaken in the Free North including projection and live-streaming. These have largely been funded by congregational giving.
