1. Purpose/Executive Summary

- 1.1 This report provides Members with an update on the work of the Registration Service in its statutory role to register life events. It provides details of the performance over the course of the last calendar year including the outcome of the external quality assurance and scrutiny the service is subject to.
- 1.2 The report also provides an update on the introduction of new arrangements for Registration on a permanent basis and future areas of development for the service.

2. Recommendations

- 2.1 Members are asked to:
 - Note the work of the Registration team across Highland and the changes to work patterns and services over the last three years.
 - Scrutinise the performance of the Registration team based upon the most recently examined data from 2021 and outlined in Appendix 4.
 - Note the future developments for the service for the next year.

3. Implications

3.1 **Resource implications:** there are no direct resource implications as a result of this report. The Registration service in Highland is integrated and provided as part of the Service Point network.

- 3.2 The service receives income for Registration services based upon fees set by National Records of Scotland. There are specific income targets for the network as part of the Council's approach to income generation.
- 3.3 **Legal implications:** The work of the Registration service is government by 9 different Acts of Parliament including:
 - The Registration of Births, Deaths and Marriages (Scotland) Act 1965
 - The Marriage (Scotland) Act 1977 and 2002
 - The Civil Partnership (Scotland) Act 2020
 - The Local Electoral Administration and Registration Services (Scotland) Act 2006
 - Certificate of Death (Scotland) Act 2011
- 3.4 **Community (Equality, Poverty and Rural):** The Registration Service is currently available in 18 locations across Highland, offering a vital service to the public in some of our most remote communities. However, the new parliamentary bill Coronavirus (Recovery and Reform) (Scotland) Act 2022 enables remote registration of both birth and death appointments on a permanent basis which has increased the reach of the service, providing greater choice for the customer. The ability to register the death of a Highland resident, with the appointment being conducted with a family member who lives elsewhere in the UK or indeed even overseas, has been an invaluable addition to the service provided.
- 3.5 **Climate Change / Carbon Clever implications:** The introduction of remote appointments which can now be conducted by telephone and/or teams will reduce carbon emissions associated with travel for both customers and for staff across our wide geographical area. Noting also fuel poverty and the current cost of living crisis, the move to remote offering and the option to carry out an appointment from a home address can be financially beneficial to the public.
- 3.6 **Risk implications:** the Passport and Identity Service have not, to date, resumed their previous partnership with the Highland Council resulting in a loss of income post-covid.
- 3.7 **Gaelic implications:** The use of Gaelic within the registers is an option with names being recorded in Gaelic, English or Gaelic *and* English, depending upon individual customer choice.

4. Background

4.1 Registration in Scotland as it is recorded today began in 1855, and information is now gathered on behalf of the Registrar General for Scotland. Registration describes the process required to register *life* events; namely Births, Deaths, Still-Births, Marriages and Civil Partnerships – both Civil and Religious. It is a legal statutory requirement to register life events which take place in Scotland. Prior to 1855, Births, Deaths and

Marriages were recorded through parish records detailing baptisms, burials and proclamation of wedding banns.

- 4.2 Registration services in Highland are delivered from:
 - 1 dedicated Registration Office serving the city of Inverness and surrounding area
 - **15** dual role offices (our Customer Service Point team) in Wick, Thurso, Golspie, Dornoch, Tain, Alness, Dingwall, Ullapool, Nairn, Aviemore, Kingussie, Fort William, Kyle, Broadford and Portree.
 - 1 partnership office in Kinlochbervie with birth and death registration being carried out by North West Citizens Advice Bureau
 - 1 "parlour" (home based) Registrar based in the Small Isles
- 4.3 These locations now offer a range of services using a wide variety of contact channels face to face, telephone, virtual and via email correspondence. Further details on the changing approach to registration provision is detailed in section 6.
- 4.4 The current staffing establishment includes:
 - 1 Chief Registrar
 - 12 Qualified Registrars (some with dual role with Service Point duties)
 - 37 Assistant Registrars (most with dual role with Service Point duties)
 - 15 Assistant Registrars employed to conduct Ceremonies Only
- 4.5 It is noted that many staff work part time hours, and most also have a dual role within their Service Point location. There are 9.74 Full Time Equivalent (FTE) qualified staff, and 31.61 FTE Assistant Registrar posts in the structure, led by the Chief Registrar.

5. Service Demand and Quality Assurance

5.1 In Scotland each year, Registrars record in the region of 140,000 life events. With around 6,000 events recorded annually in Highland this places us in the top quartile for service demand. The life events recorded for 2020 were heavily impacted by Covid, so examined figures for 2018 and 2019 are included in the table below to provide a comparison with more typical years. Figures for 2018, 2019 and 2020 are verified by National Records of Scotland and the figures for 2021 are currently provisional until examination has concluded.

Appendix 1 and 2 show the published 2018 and 2019 figures from National Records of Scotland. 2020 figures are not yet available due to delays as a result of covid.

- 5.2 Around 40% of the range of life events are registered in the dedicated office in Inverness with the rest spread across the Highlands, mostly in the larger centres of population, but it is recognised that the service is equally as important in our rural communities. Appendices 3 and 4 show the breakdown of events registered across the network, per office. However, with the introduction of a "remote" option to register an event, it is recognised that those in a rural community can do this from the comfort of their own home, without the added burden of travelling to an office, giving more flexibility to the customer and to the team to move workload when required.
- 5.3 National Records of Scotland promote Registration as "Preserving the Past, Recording the Present, Informing the Future". This highlights the importance of the information captured within the registers.

Careful and sensitive questioning by our Registrars ensure that the service accurately link life events together, for historical purposes, completing a picture of a citizen's life in Scotland. The information gathered also shapes future plans for Scotland and for the Highlands as our Vital Events branch in Edinburgh produce statistics which inform NHS, Scottish Government and Local Authorities on subjects such as causes of death linked to ethnic groups, population statistics, migration, household size, which will shape future planning such as education, housing, medical care and more.

Incorrect information recorded during a registration can cause issues with other legal documents such as passports, pensions and wills.

- 5.4 Some examples of the more complex enquiries Registrars respond to include :
 - Discussions with medical professionals regarding the information provided on the Medical Certificate of Cause of Death (MCCD)
 - Working with Procurator Fiscals and Police Scotland for sudden death registrations
 - Change of Name enquiries
 - Change of Gender enquiries
 - Family History requests
 - Requests for information for ongoing Police enquiries
 - Scrutinising paperwork in relation to marriage (Non-UK, post Brexit)
 - Working with the Home Office on marriage referrals
 - Reporting potential sham marriage to the Home Office
 - Responding to urgent Dispensation Requests (special permission) for emergency marriage ceremonies (this may due to terminal illness; or armed forces deployment)

5.5 External Quality Assurance

Each year registered events across Scotland are "examined" by a District Examiner employed by National Records of Scotland (NRS). The examiner works closely with each district office making required changes and offering advice and guidance on the law and practice of Registration in Scotland. The examiner ensures consistency in the methods of recording and gives feedback on performance for individuals and for each office. The overall local authority performance feeds into the Registrar General for Scotland's Annual Report.

5.6 The most recent annual report from National Records of Scotland is from 2019. A report for 2020 will not be issued until all the Registers from across Scotland have been gathered in by General Register Office in Edinburgh, a process which has been delayed by Covid-19. The Highland registers show a confirmed accuracy rate of 97.4%. The 2020 registers have a provisional accuracy rate of 96.7%, and the 2021 registers an accuracy rate of 97.07%. During a very difficult year for Registration teams across Scotland the service are very proud of the high standard of information captured in our Registers.

6. Looking to the Future

6.1 Remote Registration

During 2020 and much of 2021, registration services felt the full impact of Covid-19 pandemic. With office doors closing during March 2020, birth registration and marriages were suspended completely, and death registration processes changed by Royal Assent through the UK Emergency Bill, and the Coronavirus Act 2020, enabling this to be done remotely by phone.

- 6.2 Feedback from staff and customers has been the move to remote death registration has been a positive development, enabling greater flexibility and responsiveness to customers at a difficult period of their lives. Particularly within a remote area such as Highland, the move to remote death registration has assisted in reducing the need to travel.
- 6.3 Building on the learning from the pandemic, from 24th September 2022 the Coronavirus (Recovery and Reform) (Scotland) Act 2022 made provisions for the remote registration of deaths to continue on a permanent basis, and also introduced the option for a remote birth registration. Therefore, registration offices will now offer birth and death appointments both face to face, and fully remote.
- 6.4 There are benefits to both ways, as face to face gives personal contact and in certain circumstances can make communication easier, whereas remote registration is often more convenient for the customer, and can give greater flexibility to the Service, allowing us to move appointments from office to office if necessary without any disruption to the customer. This is very important in order to balance the different demands across the network and ensure the service is operating effectively and efficiently.

6.5 **Popularity of Highland as a Wedding Location**

2021 and 2022 have been particularly popular for weddings; many having been postponed as a result of the pandemic. Highland continues to be a popular choice for marriage, and areas such as Lochaber and Skye & Lochalsh experience a high volume of couples who are from outwith Highland, and indeed outwith the UK. Images shared

in appendix 5 show why our stunning landscape is so popular with visitors with couples getting married.

- 6.6 The Registration team do their best to accommodate all requests, taking into account the health and safety of staff, and the resourcing required to meet some of our more unusual locations. However, this also brings challenges that need to be managed including the remoteness of locations which may require a member of the team to be out of the office for the best part of the day often travelling to a remote location by car, boat and foot.
- 6.7 Some of our popular outdoor locations are:
 - The Quiraing on Skye this involves a narrow single track roads and a walk to the chosen spot.
 - The Old Man of Storr this is a walking boot walk of around 45 minutes.
 - Loch Coruisk a boat trip from Elgol Pier
 - The Nevis Range accessed via the Gondola
 - Castle Tioram a walk across a causeway Wellies required and tide time dependent
 - The beaches at Morar, Camusdarach and Arasaig the best part of a day out of the office
 - Glencoe taking in a vast geographical area and any number of possible locations such as The Lochan, The Study and Ralston Cairns
 - The Bone Caves at Inchnadamph a hike of around 45 minutes to a remote spot.
 - Jacobite Cruises Sailing on Loch Ness to Urquhart Bay
 - Glenfeshie Bothy, an on-foot river crossing and a 4km walk
- 6.8 The popularity of Highland for couples from outwith the UK poses particular challenges for the service with new regulations for non-UK nationals wishing to marry in the UK. Registrars perform an important role in referring couples to the Home Office and collating the necessary paperwork prior to any wedding proceeding. Overall the complexity of the process and paperwork associated with weddings has increased, which places particular time demands on the service.

6.9 Developing the Registration Service Offering

Whilst the core role of the Registration Service is statutory, the team provide a wide offering particularly for weddings. Staff encourage couples to personalise their day in many different ways, incorporating:

- Music
- Readings
- Personal Vows
- Additional enhancements such as Handfastings, Quaichs, Candle Lighting, Ring Warmings, Oathing Stones and many more.
- 6.10 Amongst the priorities for the service moving forward is the aim to develop a more cohesive package for Civil Marriage. An improved website, the use of different Social

Media platforms such as Facebook and Instagram, would assist in raising the profile and offering of the services as couples plan their special day.

- 6.11 In addition to the online offering, the service aims to start re-attending Wedding Fayres around the Highland area as a further opportunity to promote the service. Attendance at such events also helps to improve working relationships with other wedding suppliers such as venues, photographers and musicians within a local area.
- 6.12 A further area of development is to offer tailored ceremonies for other life events such as commitment ceremonies, renewal of vows and baby naming ceremonies.
- 6.13 During 2022, the service has concentrated on re-establishing itself post-covid, adapting to the new approaches and the re-arranged ceremonies. It is planned that for 2023 the focus will be on identifying opportunities for developing the service, offering new products and services and considering the potential for further income generation. It is important there is a focus on awareness raising of the range of services the Council's Registration team can offer across the Highland area; utilising technology in order to advertise and promote the service.
