# 5. Executive Search and Recruitment Services for the post of Chief Executive

There was circulated to Members only Report No. RP/2/23 by the Head of People relating to the procurement process undertaken to engage an Executive Search company to support the recruitment to the permanent Chief Executive role.

The Committee at their meeting held on 23 January 2023 agreed 6 suppliers be contacted to submit a tender responding to the specific information in the Invitation to Quote brief. Five tenders were received with one not submitting.

The Head of People, HR Manager and Talent Team undertook the evaluation process supported by Commercial & Procurement Shared Services and suppliers were ranked in order. Advice from Commercial & Procurement Shared Services was obtained to assess the financial aspect for each of the 5 bids. The Committee were invited to approve that the number 1 ranked supplier from the evaluation, FWB Park Brown Ltd be awarded the contract.

The weighting in the evaluation was queried and would be reviewed for future evaluation of the procurement.

The Committee **APPROVED** the award of contract to FWB Park Brown Ltd. The procurement process allowed for a 10 day standstill period once the contract has been awarded to allow for any challenge and if there was the Panel would be notified of this.
