

## Highland Community Justice Partnership

Minutes of Meeting held 1400 – 1600, 8 March 2023, HTSI Office, Thorfin House, Bridgend Business Park, Dingwall, IV15 9SL

#### 1. Apologies:

Notes of the previous Community Justice Partnership Meeting in December were circulated for noting.

### 4. Community Justice Update:

Margaret spoke to the items in the paper that had been circulated and mentioned that she had attended an input online in relation to the Post Custodial Partnership Plan and what this could mean for CJPs. It was agreed that Maria and Brian could possibly have a look at this and consider some options in relation to how this might work.

<u>Action</u> – Maria and Brian to consider options around the Post Custodial Partnership Plan

Margaret also mentioned the Funding Meeting that had taken place in February. The options mentioned were i) an engagement/research piece of work, ii) mentoring services and the iii) Discovery College.

It was mentioned that the mentoring services option may be too big for the amount of funding available. In relation to the Discovery College there were concerns raised about investing the money in only one third sector organisation. The group agreed that the research piece of work seemed the best use for the funds.

Mhairi will get in touch with Maria in relation to this funding.

#### 5. <u>Custody Link Worker Project Update</u>:

In Alan's absence Mhairi provided an update in relation to the paper that had been circulated.

She mentioned that Apex have indicated that they can't accept people due to their funding position due to changes in the EU/Structural Funding. This could mean that there will be no provider with experience/peer led experience to provide services for those in the justice system.

This means there will be a restriction of referrals from the Custody Link Workers.

Dougie from the National Lottery has agreed to an extension of the project for 3 months from December 2023. This means that the project will run as normal until the end of August and the Link Workers will cease to take referrals from the end of September. This will allow for a running down phase. This means that

Talks are still ongoing with HADP in relation to funding for the project and Stirling University are currently completing the evaluation.

There have been issues with some potential referrals being under 18 years and therefore, we may have to re-visit the age parameters.

#### 6. CJ Plan 2023:

Margaret spoke to the report that had been circulated and asked if the group agreed with the content.

#### 7. Finance Update:

Mhairi informed the group that there is currently £12.5k available and the CJ budget is healthy. Money has been set aside for the CJ Conference, Dragon's Den and Small Change for Justice payments and the CPO Development Officer post.

There will be another £50k and potentially £12.5k in addition to this from the annual funding.

A proposal in relation to the engagement and research work mentioned earlier will be drawn up and this will be discussed off table.

<u>Action</u> – Mhairi & Margaret to discuss proposal for Engagement/Research work

Margaret mentioned that Maria had been in touch and CJSW potentially has some funds which the partnership may wish to use. In the past funds have been used for the CPO Development Officer role and the Café Link Worker role.

#### 8. Good News:

The fact that the partnership has some disposable funding was deemed as good news.

#### 9. Partner Updates:

As Ritchie was the only partner present he updated the meeting that construction work within the Custody Centre in Inverness will begin in July for 16 weeks. This should improve the facility for everyone working there. Changes will include new intercom and CCTV systems.

#### 10.AOCB:

Ross mentioned that he and Margaret had visited the Trust Project in West Lothian College in January.

Staff from the UHI were also meant to attend as they are keen to see if they can replicate something similar in Highland. Talks are ongoing with the UHI to try and progress this work.
