Report title:	Application for the grant of a taxi driver's licence – Colin Gough (Ward 9 – Black Isle)

1. Purpose/Executive summary

1.1 This report relates to an application for the grant of a taxi driver's licence.

This item is subject to a formal hearing procedure.

2.

Recommendation

2.1 Members are asked to determine the application in accordance with the Council's hearings procedure.

3. Background

3.1 The Highland Council has resolved that in terms of the Civic Government (Scotland) Act 1982 (the "Act") a licence will be required for the driving of a taxi driver's licence. A licence for the same is issued by the Highland Council and is valid for the whole Council area.

4. Application

4.1 On 29 November 2022 an application for the grant of a taxi driver's licence was received from Colin Gough. The Act gives licensing authorities 9 months in which to determine an application, and accordingly this application requires to be determined by 29 August 2023.

5. Process

- **5.1** Following receipt of the application a copy of the same was circulated to the following Agencies/Services for consultation:
 - Police Scotland
 - Trading Standards Service
- **5.2** There have been no objections received in relation to the application.

6. Taxi Driver's Knowledge Test

6.1 Mr Gough has still to sit and pass the Council's taxi driver's knowledge test.

7.0 Right to Work Check

7.1 Mr Gough has not yet undergone a right to work check.

8. Determining issues

- **8.1** Paragraph 5(3) of Schedule 1 of the Act states that a licensing authority may refuse an application to grant or renew a licence where:
 - (a) the applicant or anyone else detailed on the application is not a fit and proper person;
 - (b) the activity would be carried out by a person other than the applicant who, if he had made the application himself, would have been refused;
 - (c) where the licence applied for relates to an activity consisting of or including the use of premises or a vehicle or vessel, those premises are not or, as the case may be, that vehicle or vessel is not suitable or convenient for the conduct of the activity having regard to
 - (i) the location, character or condition of premises or the character or condition of the vehicle or vessel,
 - (ii) the nature and extent of the proposed activity,
 - (iii) the kind of persons likely to be in the premises, vehicle or vessel,
 - (iv) the possibility of undue public nuisance, or
 - (v) public order or public safety; or
 - (d) there is other good reason for refusing the application.

If required the Principal Solicitor – Regulatory Services will offer particular advice on the criteria relating to this particular application.

8.2 A copy of this report has been sent to the applicant who has been invited to attend and will be provided with an opportunity to be heard by the Committee. He have also been advised of the procedure which will be followed at the meeting.
