Purpose/Executive Summary

- **Description:** Construction of a pumped storage hydroelectric scheme of up to 1500 megawatts generation capacity and 40 gigawatt hours storage capacity
- Ward: 20 Badenoch and Strathspey & 11 Caol and Mallaig (access)

Recommendation

Members are asked to note the submission of the PAN and highlight any material issues they wish to be brought to the attention of the applicant before the submission of the application for planning permission.

1. BACKGROUND

- 1.1 To inform the Planning Applications Committee of the submission of the attached Proposal of Application Notice (PAN).
- 1.2 The submission of the PAN accords with the provisions of the Planning etc. (Scotland) Act 2006 and was made valid on 26 June 2023. The PAN is a statutory requirement for planning applications for major or national developments and must be lodged at least 12 weeks prior to the submission of a planning application. Members are asked to note this may form the basis of a subsequent planning application.
- 1.3 The submitted information attached includes:
 - Proposal of Application Notice (Application Form)
 - Location Plan
- 1.4 In line with the Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013, the prospective developer proposes to undertake an in-person exhibition within 6 months of the date of validation (by 26 December 2023). This event will allow members of the public to engage in live discussion.
- 1.5 The consultation has been publicised and advertised in accordance with the appropriate statutory requirements with adverts placed within the Strathspey Herald and Inverness Courier on the 16th February 2023 and 17th February 2023 respectively. A letter drop to all properties within 10km of the site boundary took place on 1st February 2023. The applicant notes they have carried out an in-person public consultation event on 21st and 22nd February with dates proposed for 12th and 13th September 2023. Details of all notified parties are contained and appended to the PAN form and include Community Councils, Elected Members, local MSPs and MPs.
- 1.6 Any forthcoming application will require to be accompanied by a Pre-Application Consultation (PAC) report explaining the consultation undertaken, feedback received, and any resultant amendments made to the planning application.

2. DESCRIPTION OF PROPOSED DEVELOPMENT

- 2.1 Based upon the information provided, the development is likely to comprise of a construction of a pumped storage hydroelectric scheme of up to 1500 megawatts generation capacity and 40 gigawatt hours storage capacity associated infrastructure on 1681ha of land.
- 2.2 The applicant has not yet sought pre-application advice from the Planning Authority via the Pre-Application Advice Service for Major Developments.

3. SITE DESCRIPTION

3.1 The site is within the Adverikie Estate at Kinloch Laggan which extends to 1681ha. The site includes lower lying Lochan na h'Earba and Loch a' Bhealaich Leamhain on higher ground set back to the south of Loch Laggan. 3.2 The proposed site sits wholly in Ben Alder, Laggan and Glen Banchor Special Landscape Area (SLA), and partially in Wild Land Area (WLA) 14: Rannoch-Nevis-Mamores-Alder. The red line boundary of the development is adjacent to the boundary of Ben Alder and Aonach Beag Site of Special Scientific Interest (SSSI) and Special Area of Conservation (SAC). The designated sites lie to the southeast of the proposed upper loch 'Loch a' Bhealaich Leamhain'. This loch discharges into the Allt Cam river which feeds Loch Pattack which is part of the SSSI and SAC. The trees along the northeastern shoreline of Loch Earba are designated as Ancient Woodland.

The Proposed Development comprises construction and operation of a large-scale longduration electricity pumped storage hydroelectric scheme of up to 1500 megawatts generation capacity and 40 gigawatt hours storage capacity. Water will be stored in a lower and an upper reservoir, with water flowing between these during pumping and generating through a system of underground waterways. The lower reservoir will be created by raising the level of the existing Lochan na h'Earba from its existing top water level by constructing two new dams. The upper reservoir will be created by raising the level of Loch a' Bhealaich Leamhain by constructing a dam at its eastern end. A powerhouse would be constructed in a number of shafts on the shore of Lochan na h'Earba, with a surface building located in a cutting into the hillside to screen it from view. 
