#### 1. Purpose/Executive Summary

- 1.1 The Inverness Common Good Fund exists, under the governance of the Council with delegated powers to the City of Inverness Area Committee (CIAC) to administer, for the principal benefit of the residents of the former Burgh of Inverness. The Inverness Common Good Fund Sub-Committee (ICGFSC) have authority to allow for detailed scrutiny of the administration of the ICGF in support of the CIAC.
- 1.2 **Appendix 2** provides detail on the powers delegated from the CIAC. The ICGFSC In summary, these powers can be defined as follows;
  - Policies and Administrative Procedures relevant to the management of the grants process in respect of applications of £10,000 or less
  - All Policies and Administrative Procedures relevant to the management of all applications for Civic Hospitality
  - Promotion of the work supported by the Inverness Common Good Fund (ICGF) to include approval of logos and public relations plans
  - Power to allocate funds for any competent purpose from the Inverness Common Good Fund in respect of sums of £10,000 or less, with the proviso that this power be limited to the allocation of sums held within the current Inverness Common Good Fund budget approved by the City of Inverness Area Committee.
- 1.3 This report updates on the work of the ICGF Sub-Committee for the financial year 2022/23.

#### 2. Recommendations

2.1 Members are asked to:

- a. note and scrutinise the work of the ICGF Sub-Committee as described within the report, and
- b. Agree that powers delegated to the ICGF Sub-Committee be amended to include power to consider expressions of interest in respect of the community regeneration fund.

#### 3. Implications

- 3.1 **Resource implications** resources are required to continue to administer additional project monitoring for the operation of the ICGF Sub-Committee, and these continue to be found through making efficiencies in the application process. The Sub-Committee continued to operate on the following basis:
  - £75k was allocated to applications of £5k and under annually
  - £200k was allocated to applications of over £5k annually
  - Applications of more that £10k require CIAC approval.

The criteria for the financial year 2023/24 have changed with the focus on poverty and inequalities along with significantly reduced budget.

- 3.2 **Legal** implications- There are no legal implications as a result of this report.
- 3.3 **Community (Equality, Poverty, Rural and Island) impacts** The enhanced evaluation process for grant recipients allows for all reasonably practicable steps to be taken to ensure that Council policies are adhered to and that applicants work gives principal benefit to as wide a range of the Residents of the Former Burgh as reasonably possible.

Groups applying to the Inverness Common Good Fund must specific how their project or activity will help the Council meet its public sector equality duty, including how it may address any barriers and promote social inclusion.

#### 4. Background

- 4.1 At the City Committee meeting held on 30<sup>th</sup> November 2017, Members agreed that the Inverness Common Good Fund Sub-Committee shall be required to submit an Annual Report to the City of Inverness Area Committee summarising the work of the Sub-Committee for the immediately preceding Financial Year.
- 4.2 The ICGFSC has representation drawn from Political Groups using the agreed formula. This has produced a Sub-Committee of 11 Members which provides strong and consistent scrutiny. **Appendix 1** details the current membership.
- 4.3 A summary of the powers delegated to the Sub Committee are set out below and **Appendix 2** provides the details of the powers delegated to the Sub Committee.
- 4.3.1 <u>Grants</u> Delegated Powers to oversee the administration of the grant application process, including the setting of Grant Conditions and reviewing any decision should the circumstances of the application change or the grant remain unclaimed for more than 6 months.
- 4.3.2 <u>Civic Hospitality</u> Delegation to decide on all applications which relate to the provision of support for the Civic Office except Staffing which would remain reserved to the City of Inverness Area Committee. This power would be limited to sums of £10,000 or less
- 4.3.3 <u>City Promotions Delegated Powers to decide upon allocations to be made from the City Promotions Budget.</u> The Power would be limited to sums of £10,000 or less.
- 4.3.4 <u>City Projects/Property Maintenance</u> Powers to scrutinise and make recommendations to the City of Inverness Area Committee are included which augment the power in respect of Grant Applications in excess of £10,000.
- 4.3.5 <u>Delegation to Inverness City Area Manager</u> Power to delegate expenditure on Civic Hospitality up to a maximum of £300 per event in consultation with the Provost and Sub-Committee Chair.

#### 5. Specific Scrutiny

- 5.1 The ICGFSC has provided additional scrutiny of the following ICGF expenditure in support of:
  - Victorian Market
  - Inverness Caledonian Thistle FC Cup Final
  - Town Twinning
  - Bowling Clubs
  - Site disposal at Longman application of Community Empowerment Act
- 5.2 Additionally, CIAC asked the ICGFSC to scrutinise expressions of interest in respect of over 30 applications made to the Community Regeneration Fund. noting this, a specific additional delegated power is recommended to be added allowing the subcommittee to consider initial submissions (expressions of interest) in respect to the community regeneration fund or any other funds that may be subject to the governance of the city of Inverness area committee.

#### 6. Grants

6.1 **Appendix 3** summarises budget activity in 2022/23

- 1. Grants A budget of £275,000 was approved with funds of £270,317 being allocated in the financial year 2022/23.
- 2. Conference Support A budget of £40,000 was approved with funds of £31,800 allocated in the financial year 2022/23.
- 3. Partnership Working A budget of £151,000 was approved with funds of £149,892 allocated in the financial year 2022/23.
- 6.2 **Appendix 4** summarises the sums allocated for Grants, including Conference Support and Partnership Working in 2022/23.
  - There were 39 grant awards of under £10k totalling £193,675
  - 4 grant awards of over £10k totalling £76,642 were awarded.
  - 4 grants of £27,400 was awarded from the City Promotions Budget.
  - Conference support of £31,800 was provided
  - Grants totalling £149,892 were awarded to Inverness Business Improvement District and Visit Inverness Loch Ness for Partnership Working.
  - The total amount of grants awarded £479,409
- 6.3 Further information is provided within the regular financial reports on the ICGF taken to the ICGFSC and CIAC in due course.

#### 7. Civic Hospitality

#### 7.1 Recurring Events

**In respect of 2022/23, Appendix 5** schedules the recurring events which are supported from the Civic Hospitality budget. Prior to an event being included in this category careful consideration is given to the events status, with only those of significance to the City being included.

7.2 Efforts continued to be made to reduce the number of Recurring Events and to scrutinise applications for these in order to keep costs under control. Members will be aware that the food costs have escalated significantly and so every effort continues to be made to manage numbers in attendance at Civic events noting that no-shows are costly.

#### 8. Conclusion

- 8.1 The operational powers delegated to the Inverness Common Good Fund Sub-Committee continue to enhance the effective management of the Common Good Fund. The Sub Committee has scrutinised project funding with a focus on ensuring that projects bring principal benefit to residents of the Burgh.
- 8.2 The communications plan ensures that supported events and projects receive as high a profile as practicable. Supported projects are required to publicise that they have received support from the ICGF within all appropriate publicity.

#### **Inverness Common Good Fund Sub-Committee**

### Powers Delegated in Full by the City of Inverness Area Committee to the Inverness Common Good Fund Sub Committee

- 1. To carry out any duties delegated from the City of Inverness Area Committee in relation to the administration of the Inverness Common Good Fund.
- 2. All powers delegated shall be exercised as fully delegated powers and be applicable to the operation of the Inverness Common Good Fund.
- 3. Notwithstanding the above powers specifically delegated are;
  - a. To decide on all administrative matters relating to the operation of the Inverness Common Good Fund excepting decisions affecting Cash or Equity Investments.
  - b. Grants to decide on all applications for financial assistance where the sum applied for is £10,000 or less. In respect of applications in excess of £10,000, to make recommendations to the City of Inverness Area Committee.
  - c. Other applications for funding to decide upon all other applications for financial assistance where the sum applied for is £10,000 or less or where the sum requested relates to the provision of Staff
  - d. Project Monitoring to consider reports from officers on the progress of projects approved by the City of Inverness Area Committee and to make recommendations to the City of Inverness Area Committee as appropriate
  - e. Civic Hospitality to decide upon all applications for Civic Hospitality where the total cost of the event does not exceed £10,000, including the power to delegate approval of events to the Inverness City Area Manager in consultation with the Chair and the Provost where the cost of the event does not exceed £300.
  - f. Property Maintenance Power to scrutinise all expenditure from property maintenance budgets where the sum expended exceeds £10,000 on any one project.
  - g. City Promotions to decide upon allocations to be made from the City Promotions Budget where the sum does not exceed £10,000
  - h. Tenancy Management to decide upon all applications for lease, Assignation of Lease, Rent Review or any other Tenancy related matter where the Director of Development and Infrastructure has seen fit not exercise Delegated Powers
