The Licensing Standards Officer advised that as the outside terraced area was enclosed with an overhanging roof and three sides he was content that the local condition be amended to so that the terminal hour for this area was extended to 2300 hrs, and on the basis the terminal hour for the other outside areas remained at 2200 hrs.

The Board **AGREED** to **GRANT** the major variation of the premises licence, subject to the existing conditions and local condition (m) amended as follows:

 After 2200 hrs alcoholic or non-alcoholic drinks shall not be consumed in any outside area, other than open terraced area to the front of the hotel where alcoholic or non-alcoholic drinks shall not be consumed after 2300 hrs.
