# 1. Purpose/Executive Summary

- 1.1 This paper provides an overview of current external funding opportunities the Council is currently engaged with for Highland residents (owner occupier, private rented and social properties).
- 1.2 Outline eligibility for:
  - Energy Efficient Scotland: Area Based Scheme (EES:ABS)
  - SSE Renewable grant
  - Energy Company Obligation (ECO4)
  - ECO4 Flexible eligibility (ECO4 Flex)
  - Great British Insulation Scheme Flexible eligibility (GBIS Flex)

# 3. Implications

3.1 **Resource** – Change & Energy Team has a dedicated team to manage and coordinate the delivery of externally funded works, costs associated with the team are covered by external funding.

There is no cost implication to the Council, however there are cost saving benefits.

The team has experience delivering multi-measure contracts and energy efficiency improvements to homes throughout the Highland region. Together with extensive experience applying for and securing external funding to undertake energy efficiency works, and associated monitoring, reporting and management requirements of funding providers.

Continuing to work with the Housing section, seeking opportunities to align the delivery of the EES:ABS programme and ECO4 funding with Housing Capital plans.

Delivering collaborated area based programmes across all tenures, achieving best value and tackling fuel poverty in the region. Maximising funding opportunities for the Council by leveraging available government grants and funding from private sector.

- 3.2 **Legal** There are no legal implications arising from this report.
- 3.3 **Community (Equality, Poverty, Rural and Island)** External funding is targeted at households classed as fuel & extreme fuel poor and is available Highland wide.

Significant external grant funding is available to install energy efficiency measures which will:

- improve properties Energy Performance (EPC) rating
- reduce carbon footprint
- potentially reduce heating costs

Highland faces some of the highest levels of fuel and extreme fuel poverty across the region compared to the Scottish average<sup>1</sup>.

71% of householders in receipt of EES:ABS grant funding were classed as extreme fuel poor, 31% of extreme fuel poor households received energy efficiency improvements.

Given the level of fuel poverty in the region, the Council must continually review external funding opportunities and consider ways to maximise funding opportunities to support householders to benefit from extensive upgrades to their homes (subject to eligibility and survey). Upgrades will improve properties' EPC rating and should also support households to reach compliance with Scottish Government standards and contribute towards achieving Net Zero.

It is the Council's intention to offer whole house retrofit (where technically feasible), taking the 'fabric first' approach.

- 3.4 **Climate Change / Carbon Clever** External funding for domestic properties supports the delivery of energy efficiency measures to enable Highland households to reduce their carbon footprint and support the Council in achieving Net Zero.
- 3.5 **Risk** Householder signup remains an issue for externally funded programmes in the region. To mitigate this risk the Council has increased marketing of the EES:ABS programme for 2023/24 and continues to work closely with Home Energy Scotland and installers to provide support across the region.

One in three households in Scotland are in fuel poverty, this is across all tenures, and while funding is available to support those meeting eligibility requirements, there continues to be households falling through the cracks. The Council must look at all

external funding opportunities available to deliver energy efficiency measures to private and social properties.

The team is currently reviewing external funding opportunities which can align and expand on the work delivered under the EES:ABS programme across all tenures. Supporting the Council's objective to tackle fuel poverty and assist in a Just Transition for all.

- 3.6 Health and Safety (risks arising from changes to plant, equipment, process, or people) no risks outlined in this report.
- 3.7 **Gaelic** There are no Gaelic implications arising from this report.
- 4. Current external funding opportunities
- 4.1 Energy Efficient Scotland: Area Based Scheme (EES:ABS) is funded by the Scottish Government and is designed to tackle fuel poverty by improving domestic energy efficiency. Funding is available to Highland owner occupiers and private rented tenants in Council Tax bands A D. A <u>pre-qualification</u> form has been created on Microsoft Forms to allow householders to assess their eligibility for EES:ABS funding and will direct those who are not eligible to Home Energy Scotland for free impartial advice and support.

The SSE Renewable grant provides additional funds to reduce/ remove the requirement for a household contribution and to allow multiple measures to be delivered. Designed to support owner occupier and private rented tenants in extreme fuel poverty receiving energy efficiency improvements funded under EES:ABS or ECO4 Flex.

The Scottish Government and SSE Renewable grants are available to owner occupiers and private rented tenants (subject to eligibility), grant funding cannot be used to cover installation costs for social properties (either Council or registered landlord).

The Council can use a proportion of the EES:ABS grant administration funding to cover enabling costs (i.e. planning, surveys, scaffolding and staff costs) for improvements to Council properties when aligned with the EES:ABS programme delivered within the Climate Change & Energy Team.

- 4.2 Energy Company Obligation (ECO) has several funding steams including:
  - ECO4 Help to Heat Group
  - ECO4 Flex
  - GBIS Flex

The Council is responsible for publishing the <u>Statement of Intent</u> for ECO4 Flex and GBIS Flex, determine a mechanism for approving installers and act as a 3<sup>rd</sup> party signatory.

Appendix 1 outlines eligibility for ECO4 Help to Heat Group, ECO4 Flex and GBIS Flex.

Like EES:ABS, ECO4 is designed to target fuel poor householders. ECO4 targets:

- Lower Standard Assessment Procedure (SAP) rated properties
- Households on specified benefits
- Lower income households

People with health conditions which are impacted by living in a cold home.

ECO4 funding is available to social properties with a SAP rating E-G, to part fund the energy efficiency improvements including insulation, heating upgrades and solar PV.

Where innovative solutions are identified, ECO funding will cover social properties with SAP rating D. Innovative solutions attract funding uplifts.

ECO4 funding takes the whole house retrofit approach, focusing on fabric first, proposed works must meet a minimum requirement.

Minimum requirement means improving the energy efficiency rating of SAP band D and E properties to at least a band C, and band F and G properties to at least a band D. This increases the number of measures installed per property and the savings for the household and reduces the need for future upgrades to properties.

# 5. Marketing & Engagement

5.1 In conjunction with Corporate Communications, the team has undertaken a rebranding of all marketing material for the 2023/24 EES:ABS programme, examples in Appendix 2.

A marketing strategy for the 2023/24 has been produced by the Climate Change & Energy Team outlining various activities to raise awareness of the programme and provide further information, see Appendix 3.

2023/24 Marketing includes:

- Direct mailouts
- Social media
- Community events
- Promotional video
- Press releases

The team has held 3 community engagement events to date for the 2023/24 EES:ABS programme, Home Energy Scotland, ALIenergy and the Contractor were also in attendance for the events to answer any queries.

5.2 At the request of the Scottish Government, a member of the EES:ABS delivery team was invited to present at the Scottish Government EES:ABS officers day in November.

The presentation covered Highland Council's approach to marketing and engagement of the EES:ABS programme across the region to share with other Local Authorities the material we created along with our approach.

5.3 Presently the Council is not involved in marketing of ECO4 or GBIS schemes. Marketing for these schemes is undertaken by installers.

For ECO4 Flex and GBIS Flex, the Council provides approved installers with a verification letter which they can include alongside their marketing letter for the Flex schemes.










# Energy Company Obligation (ECO4) funding eligibility route map








# Energy Company Obligation Flex (ECO4 Flex) and Great British Insulation Scheme Flex (GBIS Flex) funding







# Appendix 2 – EES:ABS Marketing & Engagement








The EES:ABS programme provides significate Scottish Government grant funding to Highland residents offering energy efficiency measures which can lower the fuel costs and improve living conditions for the household. (Focus being 'fabric first' then heating).

### Eligibility Criteria:

- Your property is Council Tax band A, B or C (D is eligible where your Energy Performance Certificate is D, E, F or G).
- Your home is either owned by you or privately rented it must be your main residence and cannot be a second home or B&B.

# Background

The Scottish Government has awarded The Highland Council significant grant funding to deliver a Highland Energy Efficient Scotland: Area Based Scheme (EES:ABS).

EES:ABS grant funding is available to Highland homeowners and private rented tenants (subject to eligibility and survey) to make energy efficiency upgrades including insulation, installation of an air source heat pump or solar panel with battery storage to make homes more energy efficient and reduce running costs.

The Council has appointed Union Technical Services Limited as the contractor for the 2023/24 EES:ABS programme.

Union Technical will survey referred properties and outline all suitable energy efficiency measures which could be installed. Properties can receive a single measure or multiple measures.











# **Eligibility Criteria**

- Your property is Council Tax Band A, B or C
- Band D may be eligible if EPC rating is D, E, F or G
- Your home is either owned by you or privately rented must be your main residence and cannot be a second home, B&B or Airbnb
- If your property is in a conservation area or a listed building restrictions may apply

Subject to survey and eligibility criteria
