Land 2600M SW of Dunbuie Talmine Tongue

### **Purpose/Executive Summary**

- **Description:** Construction of vertical launch spaceport with launch operations control centre, site integration facility, launch pad complex, antenna park, access road, fencing, services and associated infrastructure.
- Ward: 01 North, West And Central Sutherland

### Recommendation

Members are asked to note the submission of the PAN and highlight any material issues they wish to be brought to the attention of the applicant before the submission of the application for planning permission.

# 1. BACKGROUND

- 1.1 To inform the Planning Applications Committee of the submission of the attached Proposal of Application Notice (PAN).
- 1.2 The submission of the PAN accords with the provisions of the Planning etc. (Scotland) Act 2006 and was made valid on 7 November 2023. The PAN is a statutory requirement for planning applications for major or national developments and must be lodged at least 12 weeks prior to the submission of a planning application. Members are asked to note this may form the basis of a subsequent planning application.
- 1.3 The submitted information attached includes:
  - Proposal of application Notice
  - Location Plan
- 1.4 In October 2022, The Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013 were amended by The Town and Country Planning (Pre-Application Consultation) (Scotland) Amendment Regulations 2021. This changed some of the consultation activities required by the applicant for PANs submitted after 1 October 2022. The previous arrangements associated with the Covid-19 public health advice and previous modifications to the regulations, are now superseded. In line with the current regulations, the developer proposes to undertake two in person public consultation events, in the Ben Loyal Hotel, Tongue scheduled as follows:
  - **Event 1:** Tuesday 5 December 2023, between 12-2pm and 5-8pm.
  - **Event 2:** Thursday 18 January 2024, between 12-2pm and 5-8pm.
- 1.5 The consultation was publicised and advertised in accordance with the appropriate statutory requirements, with an advert placed within the Northern Times on 24 November 2023 and for the second event, on 5 January 2023. An invitation maildrop was undertaken, during the week commencing Monday 20 November, making local residents aware of the proposed development and the consultation events. The catchment for its wider distribution covered a radius of 500m from the proposed site. The applicant has been informed of the Council's additional consultation requirement that, for proposals outwith settlement development areas identified within the Local Development Plan, all properties within 2.5km of the boundary of the proposed development should be notified by letter. The PAN form also indicates that the Tongue Community Council was notified, in line with the statutory requirements.
- 1.6 The consultation information was also made available on the applicant's website. The applicant indicated that the provision of a phone number, a further of the Council's additional consultation requirements, was discounted for technical reasons.
- 1.7 Any forthcoming application will be accompanied by a Pre-Application Consultation (PAC) report explaining the consultation undertaken, feedback received, and any resultant amendments made to the planning application.

# 2. DESCRIPTION OF PROPOSED DEVELOPMENT

- 2.1 The applicant seeks to amend the consented Sutherland Spaceport development, as originally permitted under reference 20/00616/FUL. The changes involve relocating the range tracking infrastructure to Ben Tongue, on a separate site to the east of the main complex, as well as the following amendments to the primary site:
  - Reduction in the size of the launch pad area and minor amendments to the layout of that;
  - Reduction in the area of access track that connects the launch pad to other parts of the spaceport;
  - Reduction in both the footprint and height of the launch site integration facility (LSIF) and associated yard;
  - Realignment of the access track between the A838 to the LSIF.
- 2.2 The applicant has not sought further formal advice from the Planning Authority via the Pre-Application Advice Service for Major Developments in relation to these proposed amendments, however, there has been more informal discussion between the applicants, Council Officers, Nature Scot and SEPA.

## 3. SITE DESCRIPTION

- 3.1 The main site is extensive, measuring around 330ha and is located on the north coast of Sutherland and comprises the relatively untouched landscape type of sweeping moorland and flows of A'Mhoine the peat bog which is positioned between the sea to the north and rocky hills and moorland to the south, in turn leading to the lone mountains further to the south of the site including Ben More. The site also overlooks the Kyle of Tongue to the east. The A838 north coast road runs from east to west to the south of the site and is the only significant man-made structure of A'Mhoine aside from the ruins of the Listed Moine house. Tongue village is located to the southeast, with the crofting townships of Melness and Talmine to the east, northeast and north.
- 3.2 The main site lies close to/within/on the boundary of the Ben Hutig SSSI, the A'Mhoine SSSI and the Caithness and Sutherland Peatlands SAC, SPA and RAMSAR site.
- 3.3 The Caithness and Sutherland Peatlands SPA & Ramsar site, along with the ornithological features of the A'Mhoine SSSI, recognise the international and national level of importance of the breeding birds, and their supporting habitats.
- 3.4 The Ben Hope and Ben Loyal Wild Land Area (WLA) lies approximately 0.4 km south of the main site boundary and the Kyle of Tongue National Scenic Area (NSA) is located approximately 1.7 km south east of the site at its closest point and also extends north east of the site.

3.5 The additional site for the range tracking infrastructure is located close to the summit of Ben Tongue, adjacent an existing telecoms mast, approximately 5km southeast of the main site. This further site is located partly within the Kyle of Tongue National Scenic Area (NSA).
