Report title: Application for the renewal of a skin piercing and tattooing

licence - Sleeping Beauty, 14b Margaret Street, Inverness

(Ward 14 - Inverness Central)

1. Purpose/Executive summary

1.1 This report relates to the application for the renewal of a skin piercing and tattooing licence.

This item is subject to a formal hearing procedure.

2. Recommendation

2.1 Members are asked to determine the application in accordance with the Council's hearings procedure.

3. Background

3.1 The Highland Council has resolved that in terms of the Civic Government (Scotland) Act 1982 (the "Act") a licence will be required for carrying out the activity of skin piercing and tattooing.

4. Application

- **4.1** On 3 May 2023 an application for the renewal of a skin piercing and tattooing licence was received from Lilac Miller in respect of premises at Sleeping Beauty, 14b Margaret Street, Inverness.
- 4.2 In terms of the abovementioned Act, the licensing authority have 12 months from receipt of the application to determine the same, therefore this application must be determined by 2 May 2024. Failure to determine the application by this time would result in the application being subject of a 'deemed grant' which means that a licence would require to be issued for a period of 1 year. The application is before this Committee as this is the last meeting before the determination date expires.

5. Process

- **5.1** Following receipt of the application a copy of the same was circulated to the following Agencies/Services for consultation:
 - Police Scotland
 - Fire Scotland
 - Environmental Health Service
 - Building Standards
- **5.2** Police Scotland, Fire Service and the Council's Building Standards Service have confirmed that they have no objection to the application being granted.
- 5.3 The Council's Environmental Health Service have advised that they are awaiting the following document before they can sign off the application:
 - Copy of the current electrical inspection condition report (EICR) to confirm that the fixed electrical installation is in a satisfactory condition.

6. Documents and Certification

- **6.1** As part of the licensing process a number of documents and certificates require to be submitted by the applicant.
- **6.2** At the time of writing the following has been requested, and is awaited:
 - Public Liability insurance certificate
- 6.3 As the abovementioned documents are still awaited, and an inspection of the premises has still to be undertaken, the Principal Solicitor is unable to issue the licence using delegated powers and, as indicated in paragraph 4.4 of the report, this is the last meeting of the Licensing Committee before the 12 month determination period elapses.

7. Determining issues

- **7.1** Paragraph 5(3) of Schedule 1 of the Act states that a licensing authority may refuse an application to grant or renew a licence where:
 - (a) the applicant or anyone else detailed on the application is not a fit and proper person;
 - (b) the activity would be carried out by a person other than the applicant who, if he had made the application himself, would have been refused;
 - (c) where the licence applied for relates to an activity consisting of or including the use of premises or a vehicle or vessel, those premises are not or, as the case may be, that vehicle or vessel is not suitable or convenient for the conduct of the activity having regard to
 - (i) the location, character or condition of premises or the character or condition of the vehicle or vessel,
 - (ii) the nature and extent of the proposed activity,
 - (iii) the kind of persons likely to be in the premises, vehicle or vessel,
 - (iv) the possibility of undue public nuisance, or
 - (v) public order or public safety; or
 - (d) there is other good reason for refusing the application.
- **7.2** If required the Principal Solicitor Regulatory Services will offer particular advice on the criteria relating to this particular application.
- 7.3 A copy of this report has been sent to the applicant and who has been invited to attend and will be provided with an opportunity to be heard by the Committee. They have also been advised of the procedure which will be followed at the meeting.
