Briefing on Protocol for Webcasting of Meetings

The Convener advised the Board that the meeting would be filmed and broadcast over the internet on the Highland Council website and would be archived and available for viewing for 12 months.

1. Apologies for Absence Leisgeulan

Apologies for absence were intimated on behalf of Ms E Knox and Mr D Millar.

At this juncture, the Chair informed the Committee of Mr I Cox's upcoming retirement and shared that Mr Cox was one of the original Licensing Standards Officers when the post was created back in 2009. Prior to that he had been a Police Officer with Northern Constabulary for 30 years, reaching the rank of Chief Inspector and Area Commander.

Mr Cox combined his people skills with an indepth knowledge of the law to great effect and on countless occasions used those skills to bring parties together and resolve issues before an application was presented to the Board, ensuring that on the day of the meeting, everything was able to run smoothly.

Mr Cox was widely respected and it was said that he would be greatly missed but that he had earned a long and happy retirement.

The agent for the applicant explained that the application was for a long established bowling club, which for many years ran as a unincorporated association benefitting from a members club licence. When the club was dissolved and replaced by St Fergus Bowling Club Ltd, it had the unintended consequence of bringing the existing licence to an end. This application was to reinstate the licence on a similar par and had the support of the local community council.

The Board **AGREED** to **GRANT** the application for a new premises licence subject to the mandatory conditions, local conditions (a), (b), (c), (k), (m), and (x) and the following late opening conditions:

 A person trained to the satisfaction of the Licensing Board in administering first aid must be present on the premises from 0100 hrs (on any day when the premises are open at that time) until whichever is the earlier of-

(a) the time at which the premises next close; and (b) 0500 hrs

2. A designated person who is the holder of a personal licence must be present on the premises from 0100 hrs (on any day when the premises are open at 0100 hrs) until whichever is the earlier of:-

(a) the time at which the premises next close, and

(b) 0500 hrs.

The agent for the applicant explained that this premises had been previously licenced but the licence had ended when the premises closed down. The applicant, whose principal business was closeby to this premises, saw the potential to create a community pub and function room, and would refurbish the premises upon approval of the provisional licence, which had the support of the local community council.

The Board **AGREED** to **GRANT** the application for a provisional premises licence subject to the mandatory conditions, local conditions (a), (b), (c), (k), (m), (o), and (x) and the following late opening conditions:

- A person trained to the satisfaction of the Licensing Board in administering first aid must be present on the premises from 0100 hrs (on any day when the premises are open at that time) until whichever is the earlier of (a) the time at which the premises part closes and
 - (a) the time at which the premises next close; and
 - (b) 0500 hrs
- A designated person who is the holder of a personal licence must be present on the premises from 0100 hrs (on any day when the premises are open at 0100 hrs) until whichever is the earlier of:
 (a) the time at which the premises next close, and
 (b) 0500 hrs.

There had been circulated Report No HLB/33/24 by the Clerk, which included a representation from Environmental Health regarding noise and pyrotechnics.

Given the quiet surroundings, it was felt that any noise from the hotel would stand out, however, the applicant confirmed she was happy to formulate a noise management plan, and stated she valued the good relationships held with neighbours.

The applicant was keen to extend the outdoor drinking time on the lawn from 2200 hours to 2300 hours, in order to provide patrons the opportunity to sit and enjoy the view of the Cuillin hills with an alcoholic drink, when weather permitted.

Neither the Environmental Health Officer nor the Licensing Standards Officer had any objections to extending outdoor drinking to 2300 hours, as long as a noise management plan was in place.

In terms of music, the applicant explained that the hotel catered for smaller bespoke weddings of approximately 20-30 people, with an occasional wedding of 50-100 people. Background music would be traditional, such as bagpipes fiddles or accordians, in keeping with the style of the hotel.

The Board **AGREED** to **GRANT** the major variation of the premises licence, subject to the existing conditions and additional conditions that (1) there is no outdoor drinking after 2300 hours and (2) a Noise Management Plan being agreed between the Applicant and Environmental Health.
