HOIP Performance Framework

Summary

The Highland Outcome Improvement Plan (HOIP) is the Strategic Plan for the Community Planning Partnership in Highland. Following engagement with strategic partners and across the broader partnership, the Board agreed to a revised HOIP in June 2024. This included a revised vision for the partnership, three strategic priorities and a series of supporting principles and outcomes.

As part of the revised approach, the updated Delivery Plan for the HOIP setting out seven cross-cutting themes and associated actions was agreed in September. This paper provides an update on the work undertaken since September to develop the Performance Framework for the partnership that will measure the long-term impact of the HOIP.

The Board is asked to:

i) Note the updated Performance Framework and that work will be undertaken with performance officers from across the partnership to finalise baseline indicators.

1. Background

- 1.1 At the CPP Board meeting in June, the Board agreed a revised HOIP which included:
 - An updated vision: Maximise opportunities and tackle inequality to build a thriving Highlands for all.
 - Three strategic priorities:
 - People Enable people to live independently, safe and well within their community.
 - Place Work in partnership to develop sustainable and resilient local communities.
 - Prosperity Creating opportunities for all people and places to prosper and to thrive economically
- 1.2 To support delivery of the HOIP, the Board considered a Delivery Plan comprising of seven cross-cutting themes and associated actions. The cross-cutting themes were selected on the basis that:
 - They were cross-cutting in nature and would deliver against more than one strategic priority (People, Place, Prosperity) and against more than one outcome.

- Where partnership action and activity would add value.
- They focused on areas of greatest importance across Highland.
- 1.3 As part of the revised approach, the updated Delivery Plan for the HOIP setting out seven cross-cutting themes and associated actions was agreed in September. This paper provides an update on the work undertaken since September to develop the Performance Framework for the partnership that will measure the long-term impact of the HOIP.

2. Updated Performance Framework

- 2.1 It is agreed that monitoring the impact of the HOIP overall is critical. The updated Performance Framework can be found at appendix 1 with a baseline table at appendix 2. This sets out an updated set of draft population indicators, designed to measure the impact of the HOIP at a population level. The indicators are set out under the three strategic priorities and where possible can be benchmarked against other partnership areas across Scotland.
- 2.2 The Performance Framework is a working draft with further work required with performance officers across the partnership to finalise the indicators and develop the baseline.

Recommendation

The Board is asked to:

i) Note the updated Performance Framework and that work will be undertaken with performance officers from across the partnership to finalise baseline indicators.
