- 1.1 This report provides an update to Black Isle & Easter Ross Area Committee members on progress against the priorities outlined in the Scottish Fire and Rescue Service Area Committee Plans for Black Isle & Easter Ross.
- 1.2 Priority areas are identified through a range of Intervention, Prevention and Protection activities which are delivered through partnership to reduce the risk to the communities of Black Isle & Easter Ross.

4 Black Isle & Easter Ross Area Committee Performance Report

- 4.1 The attached performance report provides the current figures for Quarters 3&4 of 2024/25 from the central Scottish Fire and Rescue Service (SFRS) performance management database against the key indicators and timelines from previous reports. Please note that turnaround times and statistics available at this time of year can be delayed and some that have not yet been processed may carry forward to the next quarter.
- 4.2 In achieving priorities within the Area Plan for Easter Ross work is ongoing within our current HFSV framework as we move towards the implementation of a new system which will significantly increase information sharing between partner agencies and ensure our resources are targeted towards the most vulnerable in our communities. PDIR's are routinely carried out at all domestic incidents regardless of type which are aimed at reducing accidental dwelling house fires following our attendance. Local engagement with academy pupils throughout the area has been targeted towards the elimination of deliberate fire setting and nuisance calls.

The Unwanted Fire Alarm Signals (UFAS) Policy provides a means of targeting premises that the Service attends repeatedly and by engagement to reduce the number of calls. This has led to a change in duty holder responsibilities in the event of an activation and work is ongoing to support premises affected by the new response procedures. This change to how we respond incidents of this type has greatly reduced unnecessary call outs which has freed up capacity to increase our operational availability, undertake more community safety prevention work and to upskill our staff and reduce operational road risk.

- 4.3 It must be emphasised that the baseline figures for some of these indicators within the report are very low and this can make meaningful statistical analysis challenging. The low figures can also make it inappropriate to provide detailed data analysis which could compromise personal information.
- 4.4 The performance report shows that Accidental Dwelling fires are above average for the area with 5 recorded Accidental Dwelling fires in this reporting period. There was 0 Fire Fatalities and 0 Non-fatal Fire Casualties in this reporting period. There was 20 Deliberate Fires in this reporting period. There were 5 recorded non-domestic fires in this reporting period.

Special Service – there were 7 road traffic collisions (RTC) reported during this period with 2 RTC Non-fatal Casualties.

From 1 July 2023, SFRS have implemented <u>UFAS incident procedure</u> following our previous <u>public consultation</u>. During this reporting period we attended 22 Unwanted Fire Alarm Signals (UFAS) incidents. This remains lower than pre 2023 figures. With this being the case, personnel will continue to work in partnership with the clear aim of trying to eliminate all incident types through our preventative work and targeted engagement with premises.

A total of 75 home fire safety visits (HFSV) were carried out during this period.














Road Traffic Collisions










Trend by Quarter (4 years)





HFSVs by Ward



New Wildfire Unit at Invergordon

Invergordon Fire Station has now received and continues with training on the new Wildfire Unit consisting of a Ford Ranger and Polaris ATV with fogging lance unit c/w trailer as part of their role as a Tier 3 station. This will greatly enhance the capability of the service locally and nationally to better deal with wildfires in the future.

The Unit will go live in mid-April once all driver/operator training has been completed, and station personnel have had the cascade training regarding fogging unit operation.



Anti-Social Behaviour Prevention

Having previously held several anti-social behaviour meetings which were very productive, and with an increase of ASB around Alness a meeting was held on 28th March 2025 at The Place in Alness.

The meeting was attended by Fire Service, Police Scotland, Education both Primary and Secondary, Highland Council including Community Support, Youth Work & Adult Learning and other stakeholders

The issues raised included fire raising/shop lifting/egg throwing/behaviour, stone throwing, abuse of The Place staff forcing closure unacceptable behaviour.

The meeting concluded with all partners agreeing to meet back in early summer with actions outlined to ensure a difference.

14. Glossary of Terms

Term - What it means

ADF

Accidental Dwelling Fire.

HFSV

Home Fire Safety Visit.

PDIR

Post Domestic Incident Response, a term used to indicate actions taken following attendance at a fire or other incident in the home. PDIRs include amongst things the offer of a free follow up home fire safety visit.

RTC

Road Traffic Collision.

Special Service

Calls to incidents which are not fires or false alarms such as RTCs, rescues, flooding, incidents involving hazardous materials or the provision of assistance to other agencies.

UFAS

Unwanted Fire Alarm Signals. When an automatic fire detection and alarm system is activated as a result of anything other than an actual fire the activation is classed as a false alarm. If an attendance is made to such an event by the Scottish Fire and Rescue Service, then the event is recorded as an UFAS incident.

UFAS Policy Change

In response to COVID, on the 6th May 2020, the SFRS decided to send 1 pump to UFAS premises that did not have their own Predetermined attendance (PDA).

As of 1st July 2023, the COVID interim 1 pump response was ended and a new UFAS policy was implemented.

The new policy is to call challenge all UFAS incidents with the intention of non-attendance. Hospitals, care homes, and sleeping risk premises are all exempt and receive either 2 pumps or their premise specific PDA.
