- 1.2 Bidh Comhairle na Gàidhealtachd a' cleachdadh Siostam Coileanaidh agus Rianachd Cunnairt (*Performance and Risk Management System* – PRMS) airson a bhith a' sgrùdadh phlanaichean corporra. Chaidh an tionndadh as ùire dhen PG aontachadh air 7 Cèitean 2024.
- 1.3 Tha dàta PRMS air a thaisbeanadh ann an cruth leabhraichean ann an **Eàrr-ràdh 1** agus gheibhear e cuideachd [an seo](#).

2. Molaidhean

- 2.1 Thathar ag iarraidh air Buill beachdachadh air an aithisg agus toirt fa-near dhan aithisg.

3. Builean

- 3.1 Goireas
Tha libhrigeadh PG air a mhaoineachadh le Comhairle na Gàidhealtachd, tabhartasan Riaghaltas na h-Alba agus diofar shruthan maoineachaidh Bhòrd na Gàidhlig (BnaG).
- 3.2 Laghail
Tha dleastanas reachdail aig Comhairle na Gàidhealtachd gum bi Plana Gàidhlig aontaichte aice a rèir Achd na Gàidhlig (Alba) 2005. Tha an dleastanas reachdail a' gabhail a-steach uallach a bhith a' buileachadh gheallaidhean PG agus cunntas ceart a thoirt seachad mun deidhinn.
- 3.3 Cunntart
Chan eil cunnartan a' tighinn am bàrr mar thoradh air an aithisg seo.

Chan eil builean Slàinte is Sàbhailteachd a' tighinn am bàrr mar thoradh air an aithisg seo.
- 3.5 Gàidhlig
Tha buaidhean fìor mhath air gleidheadh is leasachadh cànan is cultar na Gàidhlig thar nan roinnean corporra, foghlaim is coimhearsnachd. Tha seo cuideachd a' neartachadh luach sòisealta is eaconamach na Gàidhlig is a cultair co-cheangailte.

4. Buaidhean

- 4.1 Ann an Comhairle na Gàidhealtachd, tha poileasaidhean, ro-innleachdan no atharrachaidhean seirbheis uile fo ùmhlachd sgrìonadh amalaichte airson buaidh air Co-ionannachdan, Bochdainn is Còraichean Daonna, Còraichean is Sunnd Chloinne, Atharrachadh Gnàth-shìde, Eileanan is Coimhearsnachdan Dùthchail air Tìr-mòr, agus Dìon Dàta. Far a bheil feumalachd air a h-aithneachadh, thèid measadh buaidh iomlan a ghabhail os làimh.
- 4.2 Tha a bhith a' beachdachadh air buaidhean na phàirt bhunaiteach dhen phròiseas cho-dhùnaidhean agus feumaidh seo fios a chur ris a' phròiseas cho-dhùnaidhean. Nuair a thathar a' tighinn gu co-dhùnadh sam bith, feumaidh Buill aire iomchaidh a thoirt do thoraidhean measaidh sam bith.

5. Plana Gàidhlig Chomhairle na Gàidhealtachd (PG) 2024–29

- 5.1 Chaidh Plana Gàidhlig Chomhairle na Gàidhealtachd 2024–29 aontachadh le Comataidh na Gàidhlig agus leis an Làn-Chomhairle mus deach aontachadh le Bòrd na Gàidhlig air 7 Cèitean 2024. Tha adhartas gu ruige amasan a' Phlana Ghàidhlig air an sgrùdadh ann an Siostam Coileanaidh agus Rianachd Cunnairt (*Performance and Risk Management System* – PRMS). Tha an dàta PRMS ri fhaotainn ann an **Eàrr-ràdh 1** ann an cruth leabhraibh brath-ullachaidh.
- 5.2 Tha 91 gnìomhan comasachaidh ann an ceathramh PG Chomhairle na Gàidhealtachd, a tha a' gabhail a-steach ceithir cuspairean:
- Coimhearsnachdan agus Dachaigh
 - Meadhanan, Ealainean, Cultar agus Dualchas
 - Gnìomhachas agus an Eaconamaidh
 - Foghlam

Chan eilear an-dràsta a' toirt cunntas air sia de na gnìomhan comasachaidh seach nach eil iad air an clàradh airson tòiseachadh fhathast. Thathar a' dèanamh adhartas math mu choinneimh na mòr-chuid de na ceumannan. Tha ìre de shleamhnachadh ann a thaobh pròiseact Seachdain nan Deugairean chionn gu bheil air gluasad gu bhith a' ruith a' phròiseict gach dàrna bliadhna, an àite gach bliadhna, air sàillibh cosgais. Tha riarachadh caiteachais calpa airson foghlam Gàidhlig ga chur air adhart tro chòmhraidhean leantainneach leis na seirbheisean is leis na sgiobaidhean sgìreil againn. Chan eil calpa ann am Plana Tasgaidh na Gàidhealtachd gus solar 3–18 le Gàidhlig a-mhàin a sholarachadh airson Inbhir Nis,

agus mar sin tha dàil an seo an-dràsta, le obair a' dol air adhart gus roghainnean eile a chomharrachadh airson mhaoinean calpa Gàidhlig a tha glèidhte aig a' Chomhairle.

Tha mòran de na builean rùnaichte taobh a-staigh amasan na Seirbheis Corporra gan coileanadh mar-thà tro bhith a' cumail ris a' phoileasaidh is ris na stiùiridhean mu bhith a' cleachdadh na Gàidhlig ann an seirbheisean Chomhairle na Gàidhealtachd.
