Report Title: Uig Public Conveniences

1 Purpose/Executive Summary

- 1.1 The public convenience (PC) at Uig is currently in a very poor state of repair.
- 1.2 There is a new ferry terminal building due to open in the Autumn of 2025.
- 1.2 It is proposed that the Uig PC be closed on 31 August 2025, following the full commissioning of the new facilities at the ferry terminal. The new terminal includes publicly accessible toilets which will be maintained to a high standard and will be open during all ferry operating hours.

2 Recommendations

- 2.1 Members are asked to:
 - i. Agree Closure of the Uig PC from 31 August 2025; and
 - ii. **Agree** formal disposal of the asset, to allow the Uig public convenience be marketed for sale or made available for asset transfer.

3 Implications

- 3.1 **Resource** The Council currently operates 74 Public Conveniences throughout the Highlands. The function had a revenue budget of £939k (net). The current cost to operate the Uig PC is an estimated £9,372 per annum.
- 3.2 **Legal** The Council does not have a statutory responsibility to provide or operate Public Conveniences.
- 3.3 **Risk** There are no known implications arising from this report.
- 3.4 Health and Safety (risks arising from changes to plant, equipment, process, or people) There are no known implications arising from this report.
- 3.5 **Gaelic** There are no Gaelic implications arising from this report.

4 Impacts

- 4.1 In Highland, all policies, strategies or service changes are subject to an integrated screening for impact for Equalities, Poverty and Human Rights, Children's Rights and Wellbeing, Climate Change, Islands and Mainland Rural Communities, and Data Protection. Where identified as required, a full impact assessment will be undertaken.

4.3 Integrated Impact Assessment - Summary

- 4.3.1 An Integrated Impact Assessment screening has been undertaken on 15 May 2025 as detailed in **Appendix 1**. The conclusions have been subject to the relevant Manager Review and Approval.
- 4.3.2 The Screening process has concluded that there are negative impacts related to equalities and Islands and Mainland rural communities, however these are mitigated by the PC provision being available in the Uig ferry terminal building which is open when ferries are operating.

5 Background

- The existing PC located in Uig has served the community and ferry passengers for several years. However, as part of the broader redevelopment of the ferry terminal, a modern, fully accessible toilet facility has been incorporated into the new terminal building.
- 5.2 The existing PC Uig is in a very poor state of repair. In this instance, economic life expiry is taken to mean that the ongoing maintenance costs are no longer viable.
- 5.3 The average annual running costs to operate the Uig facility are shown below:-

Total	£9,372
Staffing	£4,486
Consumables	£ 852
Maintenance	£1,691
Electricity	£ 745
Water	£1,598

- 5.4 The cost to refurbish the facility is estimated at £150k and at the current time there is no capital budget available to do this.
- 5.5 An approach has been made to Uig Community Trust to discuss the possibility of taking over ownership of the Uig PC via lease or Community Asset Transfer (CAT).

6 Proposal

- The replacement of the existing PC with modern facilities at the ferry terminal aligns with current policy to consolidate services where appropriate, improve the quality and accessibility of public amenities, and reduce ongoing maintenance and operational costs. The new facilities provide a more suitable and sustainable long-term solution.
- The provision of toilet facilities within the ferry terminal ensures continued service to both residents and visitors. The ferry terminal can provide male and female toilets and changing facilities within the building. During the ferries operating hours, the building will be accessible to all.
- 6.3 It is proposed that the Uig PC be closed from 31 August 2025, and that formal disposal of the asset be approved, allowing the property to be either marketed for sale or made available for community asset transfer.
