Report Title: Ardersier Public Convenience

#### 1 Purpose/Executive Summary

- 1.1 The public convenience (PC) at Ardersier is currently in a very poor state of repair due to significant vandalism.
- 1.2 The Ardersier PC has been closed since May 2022 and it is proposed that formal closure be agreed from 31 August 2025.

#### 2 Recommendations

- 2.1 Members are asked to agree:
  - i. Closure of the Ardersier PC from 31 August 2025; and
  - ii. Formal disposal of the asset, to allow the Ardersier public convenience be marketed for sale or made available for asset transfer.

#### 3 Implications

- 3.1 **Resource** The Council currently operates 74 Public Conveniences throughout the Highlands. The function had a revenue budget of £939k (net). The current cost to operate the Ardersier PC is an estimated £12,066 per annum.
- 3.2 **Legal** The Council does not have a statutory responsibility to provide or operate Public Conveniences.
- 3.3 **Risk** There are no known implications arising from this report.
- 3.4 Health and Safety (risks arising from changes to plant, equipment, process, or people) There are no known implications arising from this report.
- 3.5 **Gaelic** There are no Gaelic implications arising from this report.

#### 4 Impacts

- 4.1 In Highland, all policies, strategies or service changes are subject to an integrated screening for impact for Equalities, Poverty and Human Rights, Children's Rights and Wellbeing, Climate Change, Islands and Mainland Rural Communities, and Data Protection. Where identified as required, a full impact assessment will be undertaken.

#### 4.3 Integrated Impact Assessment - Summary

- 4.3.1 An Integrated Impact Assessment screening was undertaken on 2 July 2025 as detailed in **Appendix 1**. The conclusions have been subject to the relevant Manager Review and Approval.
- 4.3.2 The Screening process has concluded that there are negative impacts related to equalities, however these are mitigated by the PC provision being available in Nairn to the East and Inverness to the West.

#### 5 Background

- 5.1 The existing PC located in Ardersier has served the community for several years. However, due to ongoing and significant vandalism the facility has been closed since May 2022.
- 5.2 Due to the condition of the facility and the limited maintenance budget reopening of the facility is not currently viable.
- 5.3 The average annual running costs to operate the Ardersier facility are shown below:-

Water	£2136
Electricity	£2358
Maintenance	£1075
Consumables	£2100
Staffing	£4486
Total	£12,066

The cost to fully refurbish the facility is estimated at £150k and at the current time there is no capital budget available to do this.

5.5 An approach has been made by a private individual to discuss the possibility of taking over ownership of the Ardersier PC via sale or lease.

#### 6. **Proposal**

6.1 It is proposed that the Ardersier PC be closed from 31 August 2025, and that formal disposal of the asset be approved, allowing the property to be either marketed for sale or lease, or made available for community asset transfer.
