1 Purpose/Executive Summary

- 1.1 To update members on income generated in their area via the Invitation to Pay scheme in Council operated Car Parks.

2 Recommendations

- 2.1 Members are asked to **note** the earmarked funds for this committee from the Invitation to pay Parking of £8,593.91
