Report Title: Invitation to Pay – Allocation of Income 2024/25

Report By: Assistant Chief Executive - Place

1 Purpose/Executive Summary

1.1 This report advises Members of the Invitation to Pay (ITP) income earned in 2024/25, expenditure to date and the ITP balance available. The report also proposes a process for allocating the funding.

2 Recommendations

- 2.1 Members are asked to:
 - i. **Note** the earmarked funds for 2024/25 for this Committee from the Invitation to Pay Parking of £10,453.00
 - ii. **Note** expenditure to date of income generated in 2022/23 and 2023/24 and the balance available following the addition of income earned in 2024/25;
 - iii. **Approve** the process for the distribution of Invitation to Pay income in Sutherland;
 - iv. **Note** the distribution process will be reviewed in a year's time; and
 - v. **Approve** delegated power for the authorisation of spend up to £10,000 to the Community Development Manager in consultation with local Members; while spend over £10,000 would be subject to Sutherland County Committee approval.

4 Impacts

- 4.3.2 The Screening process has concluded that the proposal has potential to have positive impact in some areas, for example income allocated to address community issues and priorities. 5 Background

- 5.1 The Council approved a £1.5m Visitor Management Strategy at its meeting on 4 March 2021 in response to the increased numbers of tourists visiting the Highlands. The strategy recognised that there was a need to invest in infrastructure and Council services to improve the visitor experience, and to address some of the issues arising from over-crowding in popular hotspots, including insufficient parking areas, bad/inconsiderate parking and consequential damage to roadside verges.
- 5.2 £250,000 from the Visitor Management Fund was allocated for improvements to parking management across Highland comprising installing charging at tourist

dominated sites, improved signage, lining, minor repairs and increasing staff resources.

- 5.3 The Sutherland County Committee agreed at its meeting on 22 November 2021 to introduce Invitation to Pay at the following locations:-
 - Achmelvich Beach Car Park
 - Clachtoll Beach Car Park
 - Durness Village Car Park.
 - Golspie Fountain Road Car Park
 - Golspie Shore Car Park

Dornoch Beach Car Park was also agreed, but it is accounted for separately because it forms part of the Dornoch Common Good Fund.

6 Invitation to Pay Income

As per Council policy, 50% of net income, after costs, are passed to the relevant Area Committee as earmarked funds from the previous financial year. The amount allocated for Sutherland County Committee to date totals £28,900 as follows:-

9 Approval Process

- 9.1 Sutherland County Committee agreed at its meeting on 12 November 2024 to allocate Invitation to Pay funds using the same process as the Ward Discretionary Fund. This process ensures support for community led activity in areas where the income generating car parks are located as well as projects across the respective ward. It is recommended that the current process for allocating Invitation to Pay funds be continued, subject to annual review.
- 9.2 All applications for funding of under £10,000 would be delegated for officer approval via the Community Development Manager in consultation with local Members. Applications for more than £10,000 would be subject to Sutherland County Committee approval, as per the Scheme of Delegation.
