1. Purpose/Executive Summary

1.1 This Report relates to applications which are currently pending for the grant or renewal of licences under the Civic Government (Scotland) Act 1982.

2. Recommendation

- 2.2 It is recommended that the Committee agree to defer the determination of the foregoing applications, either:
 - (a) to allow them to be approved under delegated powers in the event that no objections/representations are received and all outstanding documentation has been received from the applicants; or
 - (b) to a future meeting of the Committee when the applications will be determined in terms of the hearings procedure.

In terms of Section 3(1) of the abovementioned Act all applications require to be determined within 9 months of their application date otherwise the licences will be granted unconditionally for a period of 12 months. Furthermore all applications which have not been dealt with within 3 months must be submitted to the Licensing Committee for consideration.
