- 1.1 This report provides an update of key information in relation to the schools within the Glen Urquhart High Associated School Group (ASG) and provides useful updated links to further information in relation to these schools.
- 1.2 The primary schools in this area serve 211 pupils, ELC settings serve 39 children (9 in LA settings and 30 in Partner settings as at September Census), with the secondary school serving 212 young people.

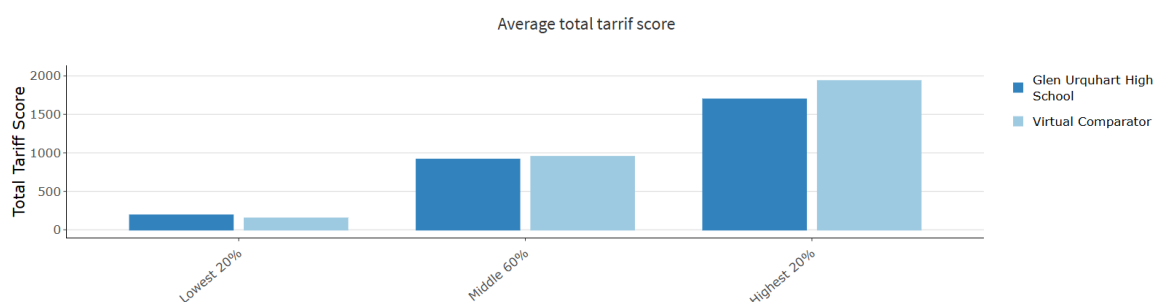

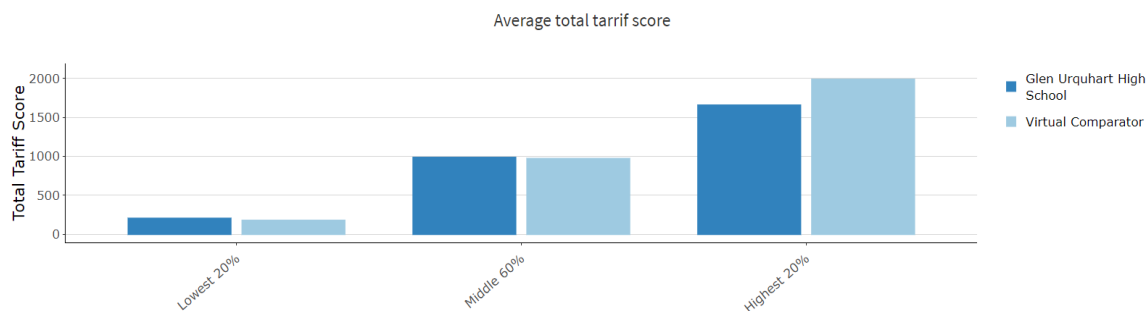

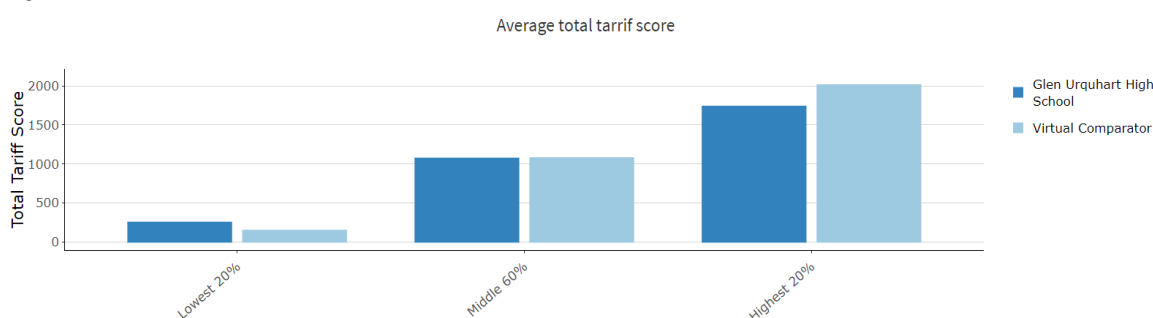
