Applications for provisional premises licences  
Achd Ceadachd (Alba) 2005  
Iarrtas airson ceadachdan thogalaichean le cumha**

**7.1 Ref: HC/CSR/2161**

**Applicant: Anthony Selvachandran**

**Premises:** Tain Superstore, 33-37 High Street, Tain

**Type:** Off Sales

There had been circulated Report No HLB/09/26 by the Clerk.

The applicant's agent spoke in support of the application.

Occasional licences had been in use since the beginning of this year without incident. There would be an accessible display of alcohol in store and an inaccessible display behind the counter. There were plans to operate home deliveries in the future. These deliveries would be made by the store's own staff and there would be no alcohol-only deliveries. The operator was experienced and the store would enhance local provisions and support customer choice.

The Board **AGREED** to **GRANT** the application for provisional premises licence subject to the mandatory conditions only.

**Applications for variation (major) to premises licences**

### **8.1 Ref: HC/INBS/468**

**Applicant:** Bradley Craig Collins, Cannich Stores, Main Street, Cannich, IV4 7LN

**Premises:** Cannich Stores/Affric Bar & Café, Main Street, Cannich, IV4 7LN

**Type:** off sales

#### **Variation:**

1. Add facility for on-sales Monday- Sunday 11.00-24.00 hrs.

2. Add following activities:

- bar meals at 5(a)
- receptions
- club group meetings at 5(b)
- background music
- televised sport at 5(c)
- outdoor drinking area

3. Add childrens' policy.

4. Add capacity for on sales.

5. Amended layout plans showing relocated off sales area with capacity increase from 10.97M2 to 26.80M2.

6. Description: Cannich Stores/Affric Bar and Cafe comprises of a traditional village shop and an adjoining bar/cafe with outdoor terrace.

7. Amend premises name to: Cannich Stores/Affric Bar and Cafe.

There had been circulated Report No HLB/10/26 by the Clerk.

The applicant spoke in support of the application.

The store was well backed by the community and employed local staff. The licence would allow the store to move forward, assist in the promotion of tourism and the operator hoped to employ a further 2-3 people, from the local community where possible, in the future.

The Board **AGREED** to **GRANT** the application for major variation to the premises licence subject to the existing conditions, additional local conditions (l) and (m), and the following special condition:

- The premises licence holder shall ensure adequate supervision of patrons using the curtilage of the premises for smoking, so that no noise nuisance is caused to nearby residents.

## **8.2 Ref: HC/RSL/1902**

**Applicant:** Black Isle Brewing Company Ltd

**Premises:** Black Isle Bar, St Mary's House, Gordon Square, Fort William, PH33 6DY

**Type:** On and off sales

### **Variation:**

#### **1. Extension of outside drinking hours:**

- Extend the permitted outside drinking hours for the external beer garden at the 'front' of the premises only from 2200 to 2300 hrs.

#### **2. Operating plan amendments:**

- Add dance facilities within core hours.
- Under 'Any Other Activities' (5(f)), replace/amend wording referring to the 'rear' external drinking area with the following:

"The external drinking area to the rear of the premises, as shown on Plan 2 of 3 of the layout plans, may be used as an additional drinking, eating and seating area as and when required."

There had been circulated Report No HLB/11/26 by the Clerk.

The Licensing Sergeant made representations to the Board in terms of Section 22 (1) (b) (ii) and (iii) of the Licensing (Scotland) Act 2005. Police Scotland felt that the 2300 termination hour for the front outside area should not be adopted due to the risk of a breach of the licensing objectives, namely preventing public nuisance. This was due to the close proximity of the premises to residential addresses and other accommodations. It was asked, if the variation was to be approved by the Board, that the Board considered the recommendations from the Environmental Health Officer (EHO) and the Licensing Standards Officer (LSO).

In response to a question from the applicant, the Licensing Sergeant stated that if the variation was to be approved by the Board, that the Board include the local conditions and special condition detailed in the Report.

In her representation, the EHO was concerned about potential public nuisance and disturbance to nearby residents, therefore the submission of a satisfactory outdoor noise management plan was necessary.

The applicant spoke in support of the application.

The applicant wished to offer quality hospitality, adopting a more mature and European style of drinking, where locals and visitors could enjoy a pizza with a glass of wine in the evening outside at the front of the premises. He did not believe that this constituted a public nuisance.

The premises, which had been awarded extended hours in 2021, operated similarly to the applicant's other premises in Inverness, which was said to operate smoothly and without issue. There were no screens or sports shown and it was said that anti-social behaviour was rare.

In response to various questions, the applicant stated that there had been no complaints received regarding anti-social behaviour, nor public nuisance, and he was confident that his staff would manage any loud behaviour. The premises stopped serving food at 2200 hours, and offered its own accommodation above the bar.

The Licensing Sergeant and EHO reiterated their representations and the Clerk highlighted that Police and EH were in agreement in terms of the local and special conditions as recommended by the LSO.

During discussion, Members appreciated the European vision but had to balance the needs of local residents and businesses.

The Board **AGREED** to **GRANT** the application for major variation to the premises licence subject to the existing conditions, additional local conditions (m) (2200 hours at rear and 2300 hours at front of premises), (o), and (p), and the following special condition:

- A written Outdoor Area Noise Management Plan, as approved by the Highland Council's Environmental Health Service, must be kept on the premises and made available to officers of the Licensing Authority or Environmental Health upon request.

### **8.3 Ref: HC/INBS/656**

**Applicant:** White River Trading Ltd, The Strathdearn, Tomatin, Inverness, IV13 7YN

**Premises:** The Strathdearn, Tomatin, Inverness

**Type:** on and off sales

#### **Variation:**

1. Q5(c) Add dance facilities, theatre facilities, films, games and sports activities.

2. Q5(f) Craft fairs, Christmas and Hogmanay events.
3. Change of description of premises.

There had been circulated Report No HLB/12/26 by the Clerk.

Speaking in support of the application, the applicant shared that the premises had operated successfully using occasional licences, however, now that the premises held weddings, community events and gatherings, a full licence would better suit requirements. The applicant accepted the LSO's recommendations and would adhere to them.

Information was sought, and provided, in terms of differing outdoor termination hours.

The Board **AGREED** to **GRANT** the application for major variation to the premises licence subject to the existing conditions, local conditions (m) (2100 hours), (n) (i), and (o).

#### **8.4 Ref: HC/INBS/348**

**Applicant:** Cabot Highlands LLP, Kinburn House, St. Andrews, KY16 9DR

**Premises:** Cabot Highlands, Balnaglack, Inverness, IV2 7JL

**Type:** on and off sales

#### **Variation:**

1. Incorporate halfway house on Castle Stuart Course.
2. Incorporate Bothy on Old Petty.
3. Add ability for mobile beverage cart.
4. Include Golf Lodge, Farmhouse and Castle Cottage.
5. Include 5 additional lodges in Phase 1, and 9 in Phase 2.
6. Layout plans to illustrate current accommodation and future planned accommodation and halfway hut and bothy.

There had been circulated Report No HLB/13/26 by the Clerk.

The premises manager spoke in support of the application.

Cabot Highlands LLP, previously known as Castle Stuart LLP, had successfully traded 17 seasons without incident. The variation would allow the ongoing growth and development of the premises, benefiting local residents and international visitors.

In response to a question, the LSO confirmed that the halfway houses would be used by golfers, caddies and guests staying in letting properties located within the licensed footprint of the premises.

The Board **AGREED** to **GRANT** the application for major variation to the premises licence subject to the existing conditions and following special condition:

- Alcohol sold from the halfway house on Castle Stuart golf course, the halfway house on Old Petty golf course, or the mobile beverage cart will only be supplied to golfers, guests, and caddies using the golf course to play golf.

## **9. Application for personal licence Iarrtas airson ceadachd phearsanta**

### **9.1 Applicant:** Kevin Tully

There had been circulated Report No HLB/14/26 by the Clerk.

The Board heard from the Licensing Sergeant who advised, in terms of Section 73 (3) (b) of the Licensing (Scotland) Act 2005, that the applicant had been convicted of a relevant offence. In terms of Section 73 (5) of the Act, information was provided in relation to the offence and the Police made no recommendation.

Mr Tully spoke in support of his application. He shared that his financial difficulties and poor mental health had led to a mistake, for which he admitted guilt. However, after having received professional support, he was now debt free and in a good place. Mr Tully spoke fondly of his employment and welcomed the opportunity a personal licence would bring to his role within Kingussie Golf Club.

During discussion, the following points were raised:-

- it was confirmed that the offence was declared on the application;
- the applicant was penitent and had been straight forward in terms of his circumstances;
- his employer had full knowledge of his history; and
- in terms of the licensing objectives, Members felt that the applicant was a fit and proper person, having acknowledged his mistake and taken steps to rectify it.

The Board **AGREED** to **GRANT** the application for a personal licence subject to the standard conditions.
