### **Purpose/Executive Summary**

This report provides an update on progress of all cases within the 'Major' and 'National' development categories currently with the Planning and Development Service for determination. The report also details progress on proposals submitted under S36 or S37 of the Electricity Act 1989 on which the Council is consulted.

### **Recommendation**

Members are asked to note the current position of these applications.

## 1. Update on Progress

- 1.1 Appendix 1 and 2 contains a list of all applications for Major Development currently with the service and awaiting determination. A brief update on the progress of these applications is provided, including a likely timescale for each case to be determined.
- 1.2 Appendix 3 provides a list of all significant Electricity Act applications. For many of these the Council has already provided its response to Scottish Government. Only once Scottish Ministers determine these cases will they be removed from the list. In terms of performance reporting, for these type of applications the Council is not required to meet the same target timescales as expected with planning applications.
- 1.3 Appendix 4 provides a list of all major scale planning permissions and Electricity Act consents issued within the last two years to provide members with an update on the status of these developments.
- 1.4 Details for any of these applications can be obtained through the Council's eplanning portal <http://wam.highland.gov.uk/wam> by entering the respective case reference number. The following abbreviations have been used in the appendices:

## 2. Delegated Refusals of Major Applications and Current Appeals / Judicial Reviews Related to Major Applications

- 2.1 Since the Major Developments Update Report presented to the last committee, the following major application has been refused using delegated powers:
- None
- 2.2 Progress with applications where the Council has raised objection:

### Grid Applications

- i. 25/03311/S37 - Spittal to Beauly 400 kV OHL - Install, operate and keep installed 173km of new 400 kV overhead electricity line, supported on steel lattice tower structures, between proposed new substations at Banniskirk (ND 15905 56823) in the area of Spittal, and Fanellan (NH 48534 43208) in the area of Beauly, with a connection via a proposed new substation at Carnaig (NH 65053 97458) near to the existing substation at Loch Buidhe, in the area of Bonar Bridge; associated permanent diversion works to 18km of existing 132 kV and 275 kV overhead electricity lines, including the temporary diversion works, and ancillary development and associated

works. The application is yet to be reported to committee, and in the absence of an agreed extension of time to respond, the Council issued an objection on 30 October 2025. Further Environmental Information was submitted in March 2026 and as of 26 May 2026 the case has been passed to the DPEA for PLI, and we await details of the Pre Enquiry Meeting. Given that public local inquiry proceedings have also commenced for the Beauly to Peterhead 400 kV OHL, that application will be firstly be reported to the South Area Committee in June 2026, ahead of the Spittle to Beauly 400 kV OHL which is now anticipated to be reported to committee in early September 2026.

- ii. 24/05153/S37 - Strathy Wood Wind Farm Grid Connection - installation and operation of approximately 4.5 km of 132 kV overhead line (OHL) on double circuit steel structure towers and the installation and operation of 2 No. trident wood H poles each with downlead spans of up to 18m from each pole for connection onto an existing trident H wood pole 132 kV OHL. Case officer issued an objection in July 2025, pending receipt and review of statutory consultee responses to the EIA Further Environmental Information. The application was reported to committee in March 2026 where Members maintained the Council's objection. A public local inquiry is anticipated to take place concurrently with Strath South Wind Farm's grid connection ahead of Scottish Ministers decision.
- iii. 25/01055/S37 - Strathy South Wind Farm Grid Connection - installation and operation of 132kV OHL on double circuit steel structure towers, approximately: Option 1, 10.5km with 8.3km installed with a future capacity of 275 kV; or, Option 2, 13.5km with 11km installed with a future capacity of 275kV comprising the removal and temporary diversion of existing OHL to allow temporary underground cabling. Case officer issued an objection in May 2025, with EIA Further Environmental Information having since been submitted. The application will be reported to committee in June 2026 ahead of public local inquiry proceedings and the application's determination by Scottish Ministers.

### **Electricity Generating Station Applications (Reported to Committee)**

- iv. 23/02998/S36 – Ben Aketil Wind Farm - Decommissioning and removal of 12 existing turbines and related infrastructure, erection and operation of 9 turbines with a maximum blade tip height of 200m, up to 20MW Battery Energy Storage System, anemometer mast, access tracks, up to two borrow pits, and all associated infrastructure. The application was reported to committee in June 2024 where, in line with the Planning Officer's recommendation, members raised an objection. A subsequent detailed report on handing was reported to committee in August 2024 which updated and refined the reasons for objection. A public local inquiry procedure took place in June 2025 and we await Scottish Ministers decision.
- v. 21/04984/S36 - Tormsdale Wind Farm - Erection and operation of wind farm for period of 30 years, comprising of 10 wind turbines with maximum blade tip height of 149.9m, access tracks, substation, control building,

Battery Energy Storage System, and ancillary infrastructure. The application was reported to committee in June 2024 where, in line with the Planning Officer's recommendation, members raised an objection. A mandatory public local inquiry procedure has been instigated. Further Environmental Information (FEI 2) proposed changes to the scheme design, including the realignment of the proposed bridge crossing of the River Thurso, removal of 1 turbine, and realignment of access tracks. The FEI 2 was reported to NPAC in September 2025 where members maintained an objection. NatureScot have also maintained their objection and we now await commencement of the public local inquiry week commencing 26 October 2026. This case will be determined by Scottish Ministers.

- vi. 23/02320/S36 - Melvich Wind Energy Hub - Erection and operation of a wind farm for a period of 40 years, comprising 12 wind turbines with a maximum blade tip height of 149.9m, energy storage facility, access tracks, borrow pits, substation, and ancillary infrastructure. The application was reported to committee in December 2023 where, in line with the Planning Officer's recommendation, members raised an objection. A mandatory public local inquiry procedure has now been instigated. Further Environmental Information has since been submitted which proposes substantial changes to the scheme design, with the proposal to now comprise 4 turbines with a maximum blade tip height of 180m and an energy storage facility with an enlarged storage capacity. On 23 October 2025 the Reporter consequently put an interim report to Scottish Ministers, setting out his recommendation that the FEI submitted by the Applicant should not be accepted as it introduced a materially different scheme from the original. The Council awaits Scottish Minister's decision.
- vii. 24/01643/S36 - Shinness Wind Farm - Erection and operation of a wind farm for a period of 40 years, comprising of 16 wind turbines with a maximum blade tip height of 200m, battery energy storage system (BESS), access tracks, borrow pits, substation, control building, and ancillary infrastructure. The application was reported to committee in December 2025 where, in line with the Planning Officer's recommendation, members raised objection. A mandatory public local inquiry procedure has been instigated with the Pre-Inquiry Meeting scheduled to take place on 6 July 2026. This case will be determined by Scottish Ministers.

### **Electricity Generating Station Applications (Pending consideration - yet to be reported to Committee)**

- viii. 23/03945/S36 - Glen Ullinish II Wind Farm - Construction and operation of a wind farm for a 40 year operational period, comprising 47 wind turbines with a maximum blade tip height of 200m, access tracks, borrow pits, battery storage, up to 2 anemometer masts, substations and ancillary infrastructure. The application was reported to committee in August 2024 where, in line with the Planning Officer's recommendation, members raised an objection. In June 2025 the applicant submitted Further Environmental Information (FEI) which proposes substantial changes to the scheme design, with the proposal to now comprise 33 wind turbines with a

maximum blade tip height of 200m. The amended scheme has undergone assessment and Officers are anticipating the application being reported to committee in Q3 2026.

- ix. 24/05152/S36 - Dalchork Battery Energy Storage System (BESS) facility with capacity of up to 249.9MW, comprising battery containers, switchgear, landscaping, CCTV access and associated infrastructure. The application is yet to be reported to committee, and in the absence of an agreed extension of time to respond, the Council issued an objection on 1 October 2025. Amendments to the application have been sought by Officers, however, in the absence of these being made, the application is anticipated to be reported to committee in Q3 2026 ahead of any public local inquiry proceedings and the application's determination by Scottish Ministers.
- x. 25/00580/S36 - Allt an Tuir Renewable Energy Park - Erection and operation of a wind farm for a period of 40 years, comprising 9 wind turbines with a maximum tip height of 200 metres, battery energy storage system, solar PV array and associated infrastructure. This case will be determined by the Energy Consents Unit. In the absence of an agreed extension of time to respond, the Council issued an objection on 3 October 2025. The application is anticipated to be reported to committee in August 2026 ahead of public local inquiry proceedings and the application's determination by Scottish Ministers.
- xi. 25/01650/S36 - Carn Fearna Wind Farm - Erection and operation of a wind farm for a period of 50 years, comprising of 9 wind turbines, 5 (T1, T2, T3, T4 and T8) with a maximum blade tip height of 200m, and 4 (T5, T6, T7 and T9) with a maximum blade tip height of 180m, access tracks, borrow pits, substation, control building, and ancillary infrastructure. The application is yet to be reported to committee, and in the absence of an agreed extension of time to respond, the Council issued an objection on 8 December 2025. The application is anticipated to be reported to committee in Q3 2026 ahead of any public local inquiry proceedings and the application's determination by Scottish Ministers.

2.3 For those cases under the Electricity Act where no objection was raised, and we are awaiting the decision of the Scottish Ministers, those cases will be listed in the appendix to this report only.

2.4 Progress with planning applications which are at appeal / have been called in for Scottish Minister's determination or are subject to judicial review:

- i. 24/05062/FUL - Carnaig Substation - Construction and operation of a 400kV substation and associated infrastructure, site access, and landscaping. The application refused at committee on 17 December 2025. An appeal to the DPEA was lodged on 18 February 2026, Case Reference: PPA-270-232, with the appointed Scottish Government's Reporter due to consider the need for any further procedure ahead of determination of the application. Usually it would be for the appointed Reporter to determine the application, however, in this case Scottish Ministers issued a direction on the 25 March 2026 confirming that Scottish Ministers will be determining the application owing to the development raising matters of national importance in the context of

National Planning Framework 4 expectations for Strategic Renewable Electricity Generation and Transmission Infrastructure.

- ii. 23/00580/FUL - Coul Links Golf Course - Construction of an 18 hole golf course, practice area, access, parking, ancillary infrastructure and the change of use of existing buildings to form clubhouse, pro shop, maintenance shed and ancillary facilities. The application was reported to committee in December 2023 where, contrary to Planning Officer's recommendation, members were minded to grant planning permission. Due to the unresolved NatureScot objection, the decision on the application has been called in by Scottish Ministers. A public local inquiry took place in November 2024. Scottish Ministers decision is awaited.
- iii. 22/02717/S36 - Strath Oykel Wind Farm and battery storage, 11 wind turbines of up to 200 metres and associated infrastructure. Having reviewed Scottish Minister's decision to consent the application, Full Council decided on 27 March 2025 to lodge a petition in the Court of Session for a Judicial Review. Following the lodging of a petition, the Court of Session quashed the decision of the Scottish Ministers to grant consent and deemed planning permission. Following this, the Scottish Ministers issued a Further Procedure Notice dated 16 September 2025, confirming that they will now reconsider the application and all the available documentation. In October 2025 the Council wrote to Scottish Ministers requesting consideration of additional matters to ensure sufficient environmental information is available to make a fully informed decision. A response from Scottish Ministers is awaited.
- iv. 24/00561/FUL – Proposed development of a battery energy storage system with a capacity of 49.9MW comprising storage containers, control building, transformers, fencing, CCTV, access, landscaping and associated works on land at 500M East Of Glengolly Farmhouse, Thurso. The application was initially reported to committee in March 2025 where members refused the application contrary to Officers recommendation. An appeal was sustained by the DPEA' appointed reporter with Scottish Ministers having granted planning permission on 30 September 2025. Having reviewed the decision of the reporter it was noted that the condition relating to socio-economic matters (NPF4 Policy 11 part c) was not attached to the decision notice. The Reporter's reasoning for doing so was because it was not required. The Council has subsequently lodged a statutory appeal under the Section 239 of the TCPA 1997 Act, as amended, asking the court to consider the adequacy of the Reporters reasoning. In accordance with the Scheme of Delegation the Chief Officer of Legal and Corporate Governance, in consultation with the Convenor, authorised the Council to lodge this appeal with the Court of Session. A substantive hearing took place on 13 May 2026, thereafter the court will consider the evidence before and issue a decision.
