

Supporting statement for submission of **Lochalsh Local Place Plan** to The Highland Council

Wednesday 11th September 2024

0. INTRODUCTION

This statement accompanies the submission of Lochalsh Local Place Plan to The Highland Council by Kyle And Lochalsh Community Trust.

The Local Place Plan can be seen online and downloaded from bit.ly/LochalshLPP.ⁱ

The Local Place Plan and this statement have been prepared in accordance with:

The area covered by the Plan is indicated by the red dashed line in Map 1 in the Local Place Plan itself (to see an online version of that map enabling accurate zooming on the boundary, visit bit.ly/LLPPboundary).

The scope of the Plan lies entirely within the areas covered by seven Community Councils:

- Dornie and District Community Council
- Glenelg and Arnisdale Community Council
- Loch Duich Community Council
- Kyle Community Council
- Lochalsh Community Council
- Plockton and District Community Council
- Stromeferry and Achmore Community Council

Within those seven Community Council areas (all of whom are members of the [Lochalsh Collaboration](#)), the Local Place Plan only includes areas that lie within the postcodes covered by Kyle and Lochalsh Community Trust as described in its Articles of Association dated 21 May 2021 (see appendix).¹ This means that some largely unpopulated areas on the northern, eastern and southern edges of the combined Community Council areas are not covered by this Plan, as shown in Map 1 in the Plan; the only permanently occupied settlement in those excluded areas is at Cluanie on the A87 near the west end of Loch Cluanie.

This Local Place Plan complements the [Lochalsh Community Action Plan](#), which was produced by local communities in 2021. This new Plan shows how local communities would like the priorities in the Community Action Plan to be implemented on the ground across Lochalsh, through a series of maps.

The Community Action Plan's vision for 2032 is of a better life in Lochalsh from the cradle to the grave, focussing particularly on:

- New parents
- Children
- Young people aged 16-30
- New parents
- Families
- Working adults
- People with disabilities or physical/mental health issues
- Older people

To achieve that vision, the Plan's top priorities are:

- Housing that is affordable on local salaries.
- Better year-round, well-paid employment.
- More training, apprenticeships & work premises.
- Childcare for parents to work & socialise.
- More cultural, sporting & social facilities & activities for all ages, especially <30s.
- Visitor facilities to increase benefit & reduce harm from tourism.
- Better social care & support locally, especially for older & disabled people.
- Mental health support services for all ages, particularly <30s.
- Better transport: public transport, walking & cycling, community transport & low carbon options.
- Recycling options locally.
- Local food: land for growing & promotion of local produce.

The Lochalsh Local Place Plan translates priorities from the Community Action Plan into actions that occupy a physical space and can be mapped. Any Community Action Plan actions that cannot be mapped continue to be very relevant, and community organisations and public agencies will continue to strive to deliver them; this Local Place Plan does not diminish or replace the unmapped priorities in the Community Action Plan.

What this Local Place Plan does is show how the Community Action Plan's vision and priorities will be implemented spatially across Lochalsh.

More generally, the purposes of the Local Place Plan are to:

- Guide planning policy and decision-making, public services and investment by the Council, its Community Planning Partners, and others.
- Provide our Community Councils with a point of reference to respond to planning applications.
- Guide our own community action and resourcing.

- Support funding bids for initiatives referred to in the plan, whether they are led by the local community or public bodies.

3. REGARD GIVEN TO EXISTING PLANS

As explained on page 10 of the Local Place Plan, whilst the plan is rooted in our community aspirations, it also reflects planning policy aims of creating sustainable, liveable and productive places as expressed in the two parts of the ‘statutory development plan’.

The proposals in chapters 2 to 10 of the Local Place Plan reflect the policy agendas contained in the statutory development plan, particularly National Planning Framework 4 and the West Highland and Islands Local Development Plan as the development plan’s most recent components.

The plan also takes account of other relevant policy documents:

- National Performance Framework 4
- National Strategy For Economic Transformation (2022)
- Highland Outcome Improvement Plan 2017-2027
- Highland Indicative Regional Spatial Strategy
- Highlands and Islands Enterprise Strategy 2023-28

Those documents share overarching objectives relating to climate change, health and wellbeing and sustainable & resilient communities.

This Plan seeks to deliver on those overarching policy objectives, plus their subsidiary agendas including active travel, community wealth- building, community empowerment, local living, rural revitalisation, a more balanced population and a growing skilled workforce.

Suggestions for the next reviews of local and national planning policy are summarised in the final chapter. We hope these will be taken into account by national and local governments. For the Local Development Plan, that next review will be taking place in the near future.

4. SUPPORT FOR THE LOCAL PLACE PLAN

For more information on the community engagement process used to develop the Local Place Plan, along with the levels of participation, please refer to chapter 1 and appendices 1-3 of the Plan itself.

The Community Trust is satisfied that the Local Place Plan provides an accurate and evidence-based representation of local residents’ views.

5. AMENDMENTS TO THE LOCAL DEVELOPMENT PLAN

The Local Place Plan contains a number of suggestions for the Council to consider as it prepares the forthcoming Highland Local Development Plan. These are contained in the tables in chapters 2 to 10 on pages 34-37 of the Local Place Plan, together with reasons, as required by Scottish Government [Circular 1-2022](#) 'Local Place Plans', paragraphs 32-33^{vii}.

We trust that the Council will find our suggestions helpful, along with those from other communities, as it develops the Highland Local Development Plan. This is an opportunity to use planning policy and other levers to more effectively tackle issues facing communities across the Highlands such as enabling access to services, facilities and opportunities; affordable housing for all; and enhanced active travel and public/community transport.

Some of the suggestions will also need changes to the 'national' part of the statutory development framework – the National Planning Framework. We request that the Council pass these suggestions on to the Scottish Government.

We would be happy to discuss our suggestions in more detail, and look forward to hearing how the Council will take account of them.
