### **The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Variation Six Ballifeary Order 2021**

NOTICE IS HEREBY GIVEN that The Highland Council on 27 April 2022 made, in terms of sections 1(1), 2(1) to (3), 4, 19, 32, 35, 45, 46, 47 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the above Order which will come into operation on 16 May 2022

The effect of the Order will be as previously advertised by Notice in the Press and Journal Newspaper dated 6<sup>th</sup> July 2021 and amended by the City of Inverness Area Committee on the 18<sup>th</sup> November 2021.

- i. Reduce the Permit Scheme to only cover that length of Ballifeary Road between its junction with Bishops Road and its junction with Ballifeary Lane.
- ii. Reduce the restricted hours to Monday – Friday 10am to 5pm.
- iii. Abandon the Permit Scheme proposed for Ballifeary Lane.
- iv. Abandon the waiting and loading restrictions from a point in line with the boundary of number 28/30 Ballifeary Road Southwards to its junction with Glenurquhart Road.

Any person wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers of the Road Traffic Regulation Act 1984, or that a requirement of that Act or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the Order was made, make application for the purpose to the Court of Session.

**The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Variation Six Ballifeary Order 2021**

Statement of Reasons

Under the Road Traffic Act 1991 the Highland Area has been designated as “a permitted parking area and a special parking area”. This designation and the variation order enable the Highland Council and its authorised officers to enforce parking, waiting and loading prohibitions and traffic restrictions within the Highland Area. Highland Council parking enforcement officers issue Penalty Charge Notices in respect of contraventions of this Order.

The above-named order will assist with traffic management in general and specifically relating to congestion experienced on the residential streets Ballifeary Road and Ballifeary Lane, Inverness

- This order will: Introduce on-street parking, waiting and loading prohibitions and restrictions and a resident permit parking scheme with permit holder bays will be introduced.

## ROAD TRAFFIC REGULATION ACT 1984

The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Variation Six Ballifeary Order 2021

THE HIGHLAND COUNCIL in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 19, 32, 35, 45, 46,47 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) as amended and of the Road Traffic Act 1991 (“the 1991 Act”) and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act of 1984, hereby proposes the following Order.

1. This Order shall come into operation on the 16 May 2022 and may be cited as “The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Variation Six Ballifeary Order 2021”
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.
4. If a court, Transport Scotland or the Parking and Bus Lane Tribunal Service for Scotland, declares any part of this Order to be invalid or un-enforceable, such declaration shall not invalidate the remainder of this Order.

5. The Highland Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2016 as amended (hereinafter referred to as the “Principal Order”) is hereby varied as follows: (i) the plans specified in Schedule 1 to this Order are deleted from the Principal Order and the plans annexed and signed as relative to this Order and listed Schedule 2 to this Order are substituted therefor and hereby added and incorporated into schedule 1 to the Principal Order; (ii) the following wording is added to Table 3.1 of schedule 3 to the Principal Order: “Ballifeary Road, Inverness”, “Ballifeary Lane, Inverness”.

This Order and the 2 schedules annexed hereto are sealed with the Common Seal of The Highland Council and signed for them and on their behalf at Dingwall on 27 April 2022 by Shona Ann Pottinger, Solicitor and Proper Officer.

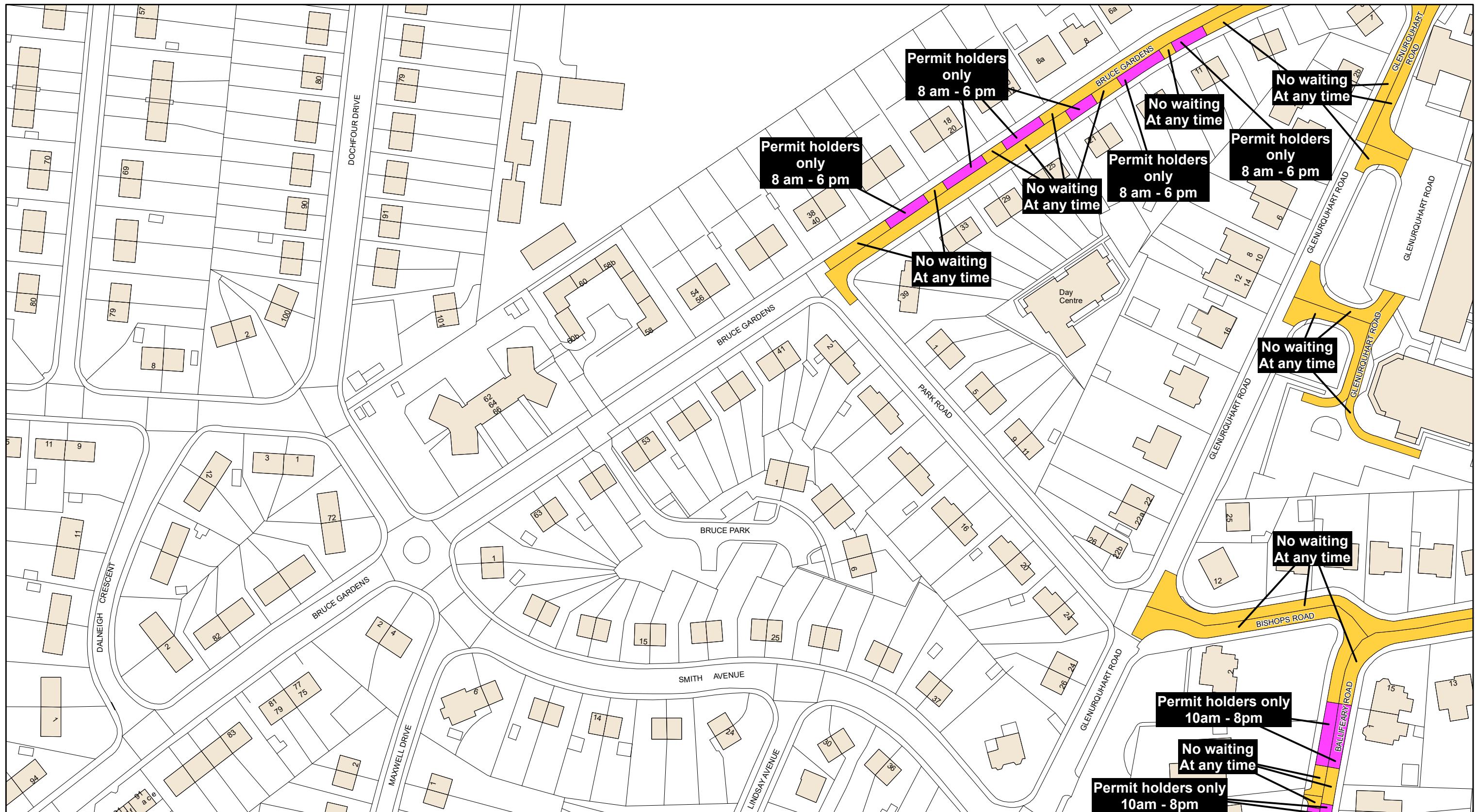

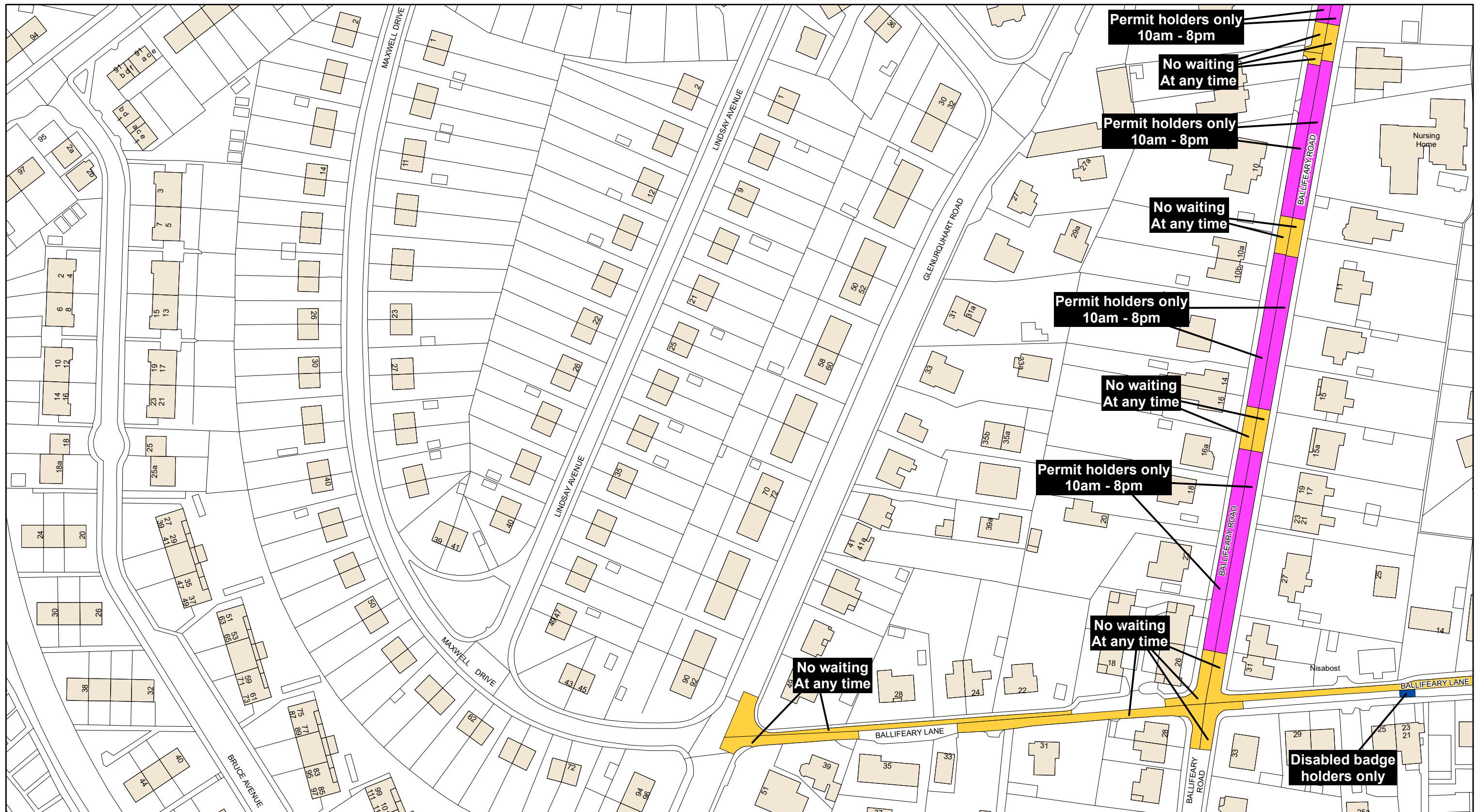

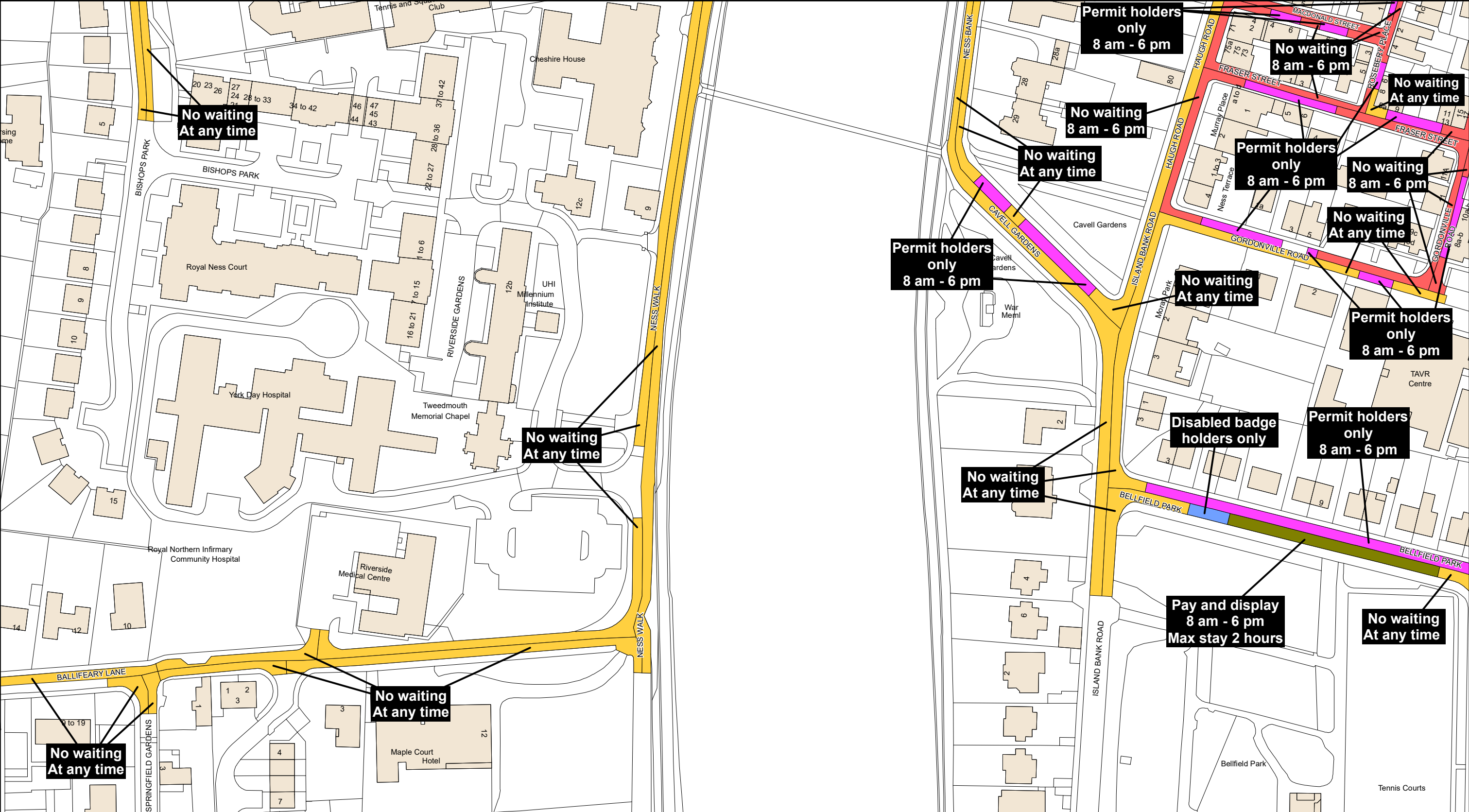
