The purpose of our proposed Local Place Plan is a chance to help shape the future of Sleat.

Introduced by the Planning (Scotland) Act 2019, LPPs give communities like ours the right to develop a plan as part of the new Scottish planning system. The community's proposals for the development and use of land in their area are at the core of the LPP and, once approved, become something Highland Council must note when making planning decisions. LPPs are based on people's aspirations, priorities and projects, co-designed within the community through a process of engagement and consultation. The

LPP process encourages us to talk about what matters and to create a vision for the future. The LPP consultation and development has been undertaken over a period of more than 6 months and involved significant numbers of residents, businesses and organisations.

The Sleat LPP is a key element of the forthcoming Highland Local Development Plan and will act as a catalyst for future funding opportunities.
