Location & Description:

The property is centrally located at the junction of High Street and Hill Street in Dingwall. The property can be accessed from Hill Street via a small stairway with paved ramp and metal balustrades. The property is shared with a local charity, which has its own separate entrance.

Internally, the property consists of a main office / shop floor. Just off of the main shop floor is a WC with sink, kitchen area, and two further separate small rooms, previously used as an office and storage. The property benefits from electric wall heaters.

The property was previously a barbers shop, which is Use Class 1A, this can be changed to Use Class 3 or 4, subject to landlord consent and applying for appropriate planning permission.

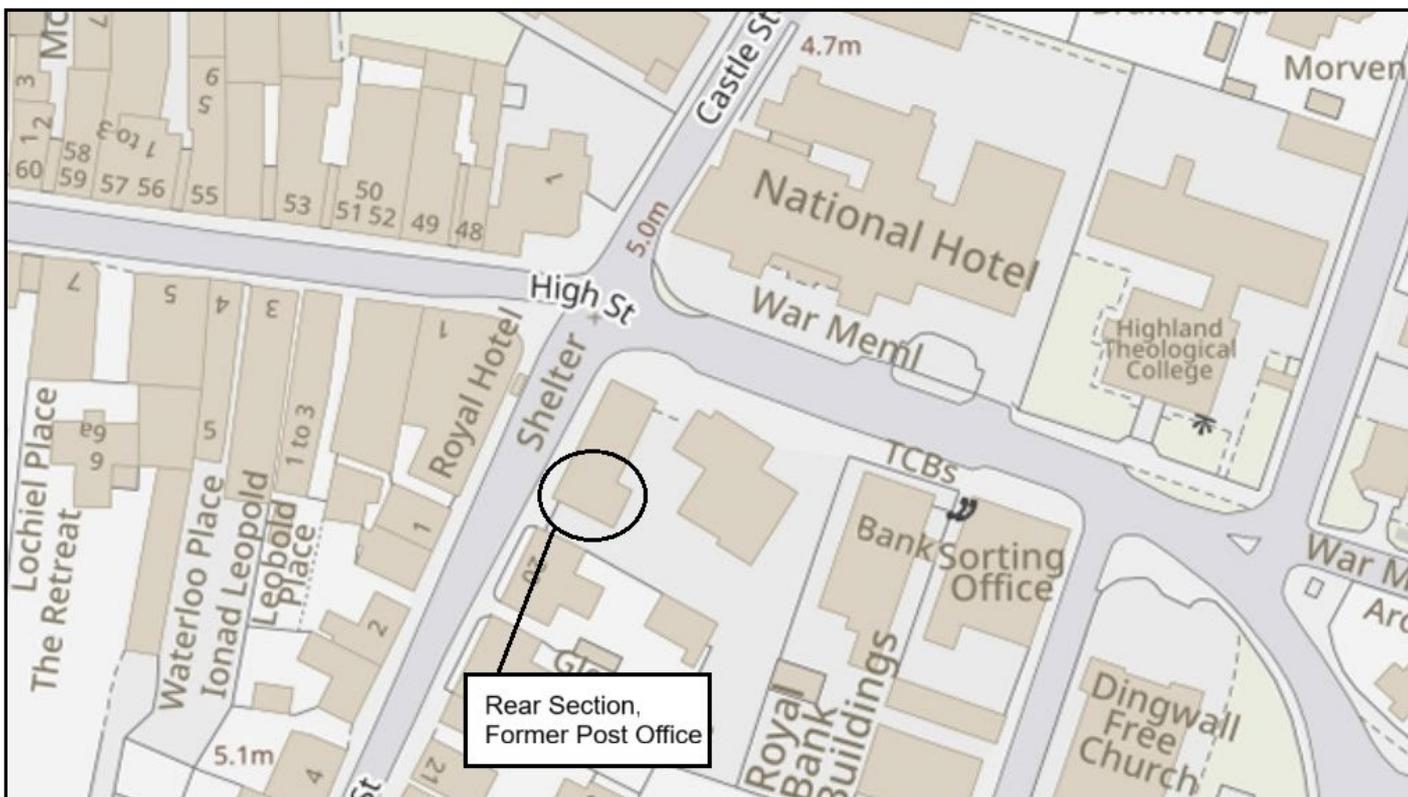
