- •Fran and Richard declared an interest in the Gairloch Heritage Museum but had no direct involvement with the organisation or project members agreed that there was no need to withdraw from discussion
- •Councillors Greene and Campbell highlighted that, in their role as local councillors, they had a general interest in many organisations and projects in the WRSL area but members agreed that there was no need for councillors to declare interests or withdraw from discussions unless they had a direct involvement in the applicant organisations/projects or direct involvement in the approval of any funding for the applicant organisations/projects.

#### **DEVELOPMENT OFFICER UPDATE:**

- Future WRSL LAP meeting dates listed below
- LARCS, the new online LEADER application system, is now live and Development Officers have received training.
- •21 EOIs received as at 23.8.16 of which 2 have been withdrawn and 2 related to Private Business/Rural Enterprise Enterprise no LAP Member discussion on EOIs.
- •7 Pre-application forms issued as at 16.8.16 of which 6 have been completed and returned requesting a total of £189,935 of LEADER grant.
- •No Full Application forms submitted to date
- •Rural Enterprise/Farm Diversification Sub-group of the LAG now formed and currently developing eligibility criteria/priorities. Grant funding thresholds previously agreed as Maximum £100K and Minimum £5K. More information expected after the 31 August LAG meeting.
- •Currently awaiting news from Scottish Government about possible impact of UK's decision to exit EU on the LEADER programme budgets and timescales. All LAP members should have received an email update and further information will be circulated when available.
- •THC, as the accountable body, will not be issuing offers of LEADER grant until the Scottish Government can provide assurances that the current indicative LEADER budgets and the LEADER Programme period will continue to be honoured following the result of the EU referendum
- •LAP members were asked to promote LEADER and to try to identify potential LEADER eligible projects especially those that had their match funding in place and could quickly complete and claim
- Equalities Reference Group Project assessment/scoring criteria agreed and projects scoring less than 6 will be referred to the ERG for advice/support relating to best practice.
- •Slightly amended Pre-application Form and Guidance notes have been agreed by the LAG this form and stage will be reviewed by the LAG after 3 months (5 of the 6 pre-application forms received to date are old style). All future Pre-application forms submitted should be new style.
- •DOs will complete a technical check of Pre-application forms checking: project fit with LDS outcomes/activities; project suitability for LEADER as opposed to other SRDP funding; that level of LEADER funding requested fits local area criteria; and for any identifiable LEADER ineligible activities) with LAPs undertaking the assessment/scoring of pre-application forms as per the assessment/scoring template provided.
- •Currently the deadline for receipt of Pre-applications is 1 month prior to LAP/LAG meeting at which it will be considered and deadline for receipt of Full Applications is 2 months prior to LAP/LAG meeting at which it will be considered.
