WELCOME AND INTRODUCTIONS: AM welcomed everyone

DEVELOPMENT OFFICER UPDATE:

- Full applications approved to date x 1

- EOIs with outstanding LEADER queries and/or no recent contact following feedback x 11

- Members were notified that an enquiry about whether a community council (which was not operating when the LAP was established) could now nominate a representative to join the LAP. DO had responded indicating that any nomination should be submitted along with a biography of nominee's skills for consideration by the LAP. Members considered that joining the LAP at this late stage of the LEADER Programme might not be easy unless the proposed member had previous LEADER/LAP experience but that any nominations would be considered.
- Because Highland LEADER grants are released on bank statement evidence of payment of
 project expenditure the Highland Council has recently agreed to make £250k available in
 cashflow finance to help support delivery of LEADER funded projects although it is
 expected that demand for this cashflow facility will be oversubscribed and that not all
 applicants who require cashflow support will be successful in securing it from this fund. It

is envisaged that finance will be available to successful applicants for certain "crunch" points in the project rather than being used to cashflow a whole project from start to finish.

- BREXIT will result in the Highland LEADER Programme coming to an end following the UK's exit from the EU and the current best guess for the date of BREXIT is March 2019.
- LEADER applicants should therefore be aware that all Highland LEADER funded project activities should be completed by March 2019. Applicants intending to apply to the Highland LEADER Programme for grant funding should also do so as soon as possible.
- Prior to submitting a LEADER application, an Expression of Interest form detailing an
 outline of the project and its estimated project costs, LEADER grant request, etc must be
 completed/submitted to enable the LEADER eligibility of the project to be assessed.

- If LEADER eligibility is confirmed at Expression of Interest stage, an applicant would be invited to progress to a full application as soon as clearly defined project costs, project match funding and any required permissions/consents and security of tenure, etc, are in place.
- LEADER applicants should be aware that evidence of clearly defined project costs and match funding and, for capital projects, evidence of any required project permissions/consents and security of tenure should be in place **before** any LEADER application can be considered.
- The WRSL LAP are currently considering LEADER applications every 3 months with the deadline for receipt of applications currently set at 2 months before the relevant meeting date at which an application will be considered. The WRSL LAP's remaining 2017 meeting and application deadline dates are as below.

 LAP Members agreed that applying to LEADER was not a simple process and that, for some community groups, successfully getting through the application process and claiming the funding would often be reliant on involving professional advisory support which was disappointing
